



How artefacts are identified

Processing of food required grinding equipment as well as vessels for mixing, blending and cooking. These were made of stone, metal and terracotta. This is an excerpt from one of the earliest reports on excavations at Mohenjodaro, the best-known Harappan site:

Saddle querns.... are found in considerable numbers... and they seem to have been the only means in use for grinding cereals. As a rule, they were roughly made of hard, gritty, igneous rock or sandstone and mostly show signs of hard usage. As their bases are usually convex, they must have been set in the earth or in mud to prevent their rocking. Two main types have been found: those on which another smaller stone was pushed or rolled to and from and others with which a second stone was used as a pounder, eventually making a large cavity in the nether stone. Querns of the former type were probably used solely for grain; the second type possibly only for pounding herbs and spices for making curries. In fact stones of this latter type are dubbed "curry stones" by our workmen and our cook asked for the loan of one from the museum for use in the kitchen.

Irrigating trees and fields

This is an excerpt from the Babur Nama that describes the irrigation devices the emperor observed in northern India:

The greater part of Hindustan country is situated on level land. Many though its towns and cultivated lands are, it nowhere has running waters. For water is not at all a necessity in cultivating crops and orchards. Autumn crops grow by the downpour of the rains themselves; and strange it is that spring crops grow even when no rains fall. (However) to young trees, water is made to flow by means of buckets or wheels...

In Lahore, Dipalpur (both in present-day Pakistan) and those other parts: people water by means of a wheel. They make two circles of rope long enough to suit the depths of the well, fix strips of wood between them, and on these fasten pitchers. The ropes with the wood and attached pitchers are put over the wheel- well. At one end of the wheel-axle, a second wheel is fixed, and close to it, another on an upright axle. The last wheel the bullock turns; its teeth catch in the teeth of the second (wheel), and thus the wheel with the pitchers is turned. A trough is set where the water) empties from the pitchers und from this the water is conveyed everywhere.

Buchanan described the ways in which the Jotedars of Dinajpur in North Bongal resisted being disciplined by the zamindar and undermined his power:

Landlords do not like this class of men, but it evident that they are absolutely necessary, unless the landlords themselves would advance money to their necessitous tenantry...

The jotedars who cultivate large portions of lands are very refractory, and know that the zamindars have no power over them. They pay only a few rupees on account of their revenue and then fall in balance almost overy kist (instalment), they hold more lands than they are entitled to by their pottaha (deeds of contract). Should the zamindar's officers, in consequence, summon them to the cutcherry, "and detain them for one or two hours with a view to reprimand them, they immediately go and complain at the Fouzdarry Thanna (police station) for imprisonment and at the munsiff's (a judicial officer at the lower court) cutcherry for being dishonoured and whilst the causes continue unsettled, they instigate the petty yots not pay their to consequently revenue consequently ...



- (iv) Rituals associated with the structure concluded with the Dussehra, Durga Puja or Navaratri.
- (v) The kings displayed their prestige, power on the occasion.

- (vii) The state horse was worshipped.
- (viii) A ceremony of sacrificing animals.
- (ix) Dances, wrestling matches.
- (x) Processions of decorated horses, elephants, chariots, soldiers,
- (xi) Ritual presentations of Nayakas before the king.
- (xii) The king inspected the armies of Nayakas.
- (xiii)Gifts, tributes were given by Nayakas to the king.
- (xiv) The Mahanavami Dibba remains an enigma for many scholars. (Any Three Points) (1×3=3)
- **25.** The position of the Zamindars in the Mughal Village Society can be explained with the following points:
 - (i) The Zamindars held a prominent position in the Mughal village society and were bestowed with several essential functions.
 - (ii) They were responsible for the collections of the land revenue from the peasants which was fixed by the Mughal Court.
 - (iii) The zamindars also used to possess other resources associated to the military and used to perform important duties for the state due to which they had high position in the state.

- (iv) The Zamindars were at the forefront of all the agricultural activities that took place in their respective villages. (Any Three) (1×3=3)
- 26. One of the topics most vigorously debated in the Constituent Assembly was the respective rights of the Central Government and the States. Jawaharlal Nehru argued for a strong centre in the draft Constitution. The need for a strong Centre had been underlined on numerous occasions.

The Constitution provided three lists of subjects: Union, State and Concurrent. The subjects placed in the first list were for the Centre and more items were placed for the Union control than the other federations and more placed for the concurrent list than desired for the provinces. The Union also had control over minerals and key industries. Moreover, Article 356 gave power to Centre to take over the State administration on the recommendation of the Governor. Dr. Ambedkar had declared that he wanted "a strong and united Centre, much stronger than the Centre we had created under the Government of India Act, 1935".

Many members felt that the Centre must be strong enough to stop the communal riots and violence. Gopalaswami Iyenger declared that "the Centre should be made as strong as possible". Balakrishna Sharma, reasoned at length that only a strong Centre could plan for the well-being of the country, mobilise the available economic resources, establish a proper administration and defend the country against foreign aggression.

- **27. (a)** The Rebel Proclamations in 1857 repeatedly appealed to all sections of the people, irrespective of their caste and creed:
 - (i) Appeal to religious unity: The proclamation called upon all Hindus and Muslims to unite against the British and fight for their common cause. It is significant, as India was a multireligious society, and the British had tried to divide and rule by exploiting religious differences.
 - (ii) Appeal to regional unity: This appeal to regional unity was important because India had many regions with distinct identities, languages, and cultures, and the British had tried to exploit these regional differences.
 - (iii) Appeal to social unity: The proclamations also appealed to social unity. The proclamation of Rani Lakshmi Bai of Jhansi, a woman warrior who fought against the British, called upon all castes and classes to unite against the British.

(b) The leaders of the revolt were presented as heroic figures leading the country into battle, rousing the people to righteous indignation against oppressive imperial rule. Heroic poems were written about the valour of the queen who, with a sword in one hand and the reins of her horse in the other, fought for the freedom of her motherland. Rani of Jhansi was represented as a masculine figure chasing the enemy, slaying British soldiers and valiantly fighting till her last. Children in many parts of India grow up reading the lines of Subhadra Kumari Chauhan: "Khoob lari mardani woh to Jhansi wali rani thi" (Like a man she fought, she was the Rani of Jhansi). In popular prints Rani Lakshmi Bai is usually portrayed in battle armour, with a sword in hand and riding a horse - a symbol of the determination to resist injustice and alien rule.

28. (a) Town planning was an exceptional feature of the Indus Valley Civilization. Their town planning has surprised archaeologists of the world. The people of the valley had built their cities with proper planning and with a fixed pattern. Some essential features of the town planning were:

Pattern of streets

- (i) The streets were straight and cut each other at right angles.
- (ii) The roads were made to divide the city into rectangular blocks and were made using burnt brick.
- (iii) Lamp posts have been also found at regular intervals. (Any Two)

The Great bath

- (i) The most crucial structure of Mohenjodaro was the great bath.
- (ii) A large rectangular tank was inside the city. Burnt bricks were used to make the floor of the great bath.
- (iii) It was like a modern-day swimming pool with considerable drain that was used to drain the water.
- (iv) There were rooms near the great bath that were used as changing rooms. (Any Two)

Drainage system

- (i) A unique feature of this civilization was the closed drainage system, which most cities featured.
- (ii) Every house was home to a courtyard, a bathroom.
- (iii) The drains of the kitchen and the toilet were connected to the gutters of the streets.

- (iv) The roads had underground drains.
- (v) The wastewater travelling from flushing toilets went into one of several sewage pipes that carried out this water into the river or sea.

(Any Two)

Other main characteristics of town planning were follows:

- Each city was divided into two parts-the raised area called the 'Citadel' and the 'lower town.'
- (ii) The main streets followed a grid pattern running from north to south or from east to west.
- (iii) The houses at street corners were rounded to allow carts to pass easily. (Any Two) (8)

(b) Here are some of the significant contributions made by archaeologists from 1875 till 1950:

Alexander Cunningham: Alexander Cunningham was the founder of the Archaeological Survey of India. In 1875, Cunningham excavated the ancient city of Harappa in present-day Pakistan, which was the first site of the Harappan civilization to be discovered. He noted that the amount of brick taken from the ancient site was enough to lay bricks for "about 100 miles" of the railway line between Lahore and Multan

He collected:

- (i) Harappan seal
- (ii) Terracotta objects
- (iii) Harappan inscriptions
- (iv) Harappan artefacts
- (v) Chinese Buddhist pilgrim's accounts

John Marshall: John Marshall succeeded Cunningham as the Director-General of the Archaeological Survey of India. In the 1920s and 1930s, he led excavations at several Harappan sites, including Mohenjo-daro, which is one of the largest and most well-preserved cities of the Harappan civilization. He announced the discovery of the Harappan civilization to the world based on excavations of D. R. Sahni and R. D. Banerji and evidence found in Mesopotamia.

- R. D. Banerji: R. D. Banerji was a prominent archaeologist who worked closely with Marshall during the excavation of Harappan sites. He is credited with discovering the ancient city of Kalibangan in present-day Rajasthan, which was one of the easternmost sites of the Harappan civilization.
- 29. (a) Kabir Das is one of the most renowned poetsaints who has given his views on several important aspects related to social situations, institutions and ultimate reality. Some of his views are:

- (i) Kabir Das believed in living a simple life and restrained from possessing too many materialistic things.
- (ii) Kabir Das had faith in an abstract deity. Many individuals from many groups adopted his beliefs.
- (iii) Vehemently opposing the main religious traditions, Kabir's ideas were radical.
- (iv) Throughout his teachings, he mocked various Muslim, Hindu, and Brahmanical forms of exterior devotion. He once preached harmony between Muslims and Hindus.
- (v) He thought God was the same person behind various guises. He believed in a Supreme God who had no form. Furthermore, he asserted that bhakti, or devotion, was the only way to reach salvation.
- **(vi)** Together with that, he delivered sermons on the need of human brotherhood.
- (vii) He opposed the caste system and did not support it. His poetry was written in spoken Hindi, which made it simple for regular people to grasp. Both Muslims and Hindus are among his believers.
- (viii) Kabir believed in the virtue of truth. He asked everyone to follow the path of righteousness and said serving others serves God. (1×8=8)

OR

- (b) (i) Sufi Silsila began to flourish in different parts of Islamic world around the 12th century. The literal meaning of Silsila was a chain, signifying a continuous link between master and disciple.
 - (ii) The Chishtis were the Sufis who migrated to India in the late 12th century. They were highly influential in the sub-continent. They easily adapted to the local environment and adopted features of Indian devotional traditions.
 - (iii) With the expansion in the popularity of Shaikh Nizamuddin, an important Chishti teacher, their teachings, practices and organisation began to be spread throughout the country. The people from different creeds, classes and social backgrounds started expressing their dedication at the dargahs of the five great Chishti saints.
 - (iv) The Chishtis mostly used Hindavi, the local language of the people for conversations and talks in Delhi and other places. Most of them used local language in their writings and scriptures. Sufis such as Baba Farid composed

- his verses in the local language. His verses are found included in the Guru Granth Sahib.
- (v) Many others composed poems and masnavis to express ideas of divine love. All these helped them to easily adapt to the local culture and environment.
- (vi) A major characteristic of the Chishti tradition lies in strict austerity including maintaining distance from the worldly power.
- (vii) But, the Sufis accepted grants and donations from the kings and elites. They accepted these donations both in cash and kind. But mostly they preferred to have their immediate requirements of food, clothes, living quarters and ritual necessities fulfilled rather than having accumulated donations.
- (viii) All this enhanced their social position and helped them adapt to the local environment and adopt features of the Indian devotional traditions. (1×8=8)

30. (a) Causes of Quit India Movement

- (i) The immediate cause of the Quit India movement was the collapse of Cripps Mission.
- (ii) The INC did not grant unconditional support to the Britishers during World War II as was assumed by the Britishers.
- (iii) The feeling of nationalism and self-rule had gained popularity among the Indian masses.

Events of Quit India Movement: Quit India Movement had three phases:

First Events of Quit India Movement:

 In the first events, there were countrywide strikes and demonstrations. Mahatma Gandhi was imprisoned in the Aga Khan Palace in Pune. Many other leaders were also detained by the Britishers.

Second Events of Quit India Movement:

 The second events of the Quit India Movement saw many peasant rebellions marked by the uprooting of communication systems, such as railway tracks and stations, telegraph wires and poles, attacks on government buildings or any other visible symbol of colonial authority.

Third Events of Quit India Movement:

 The third and final events of the Quit India Movement witnessed the formation of national governments or parallel governments in isolated pockets such as Ballia, Tamluk, Satara etc.

- The masses took active participation in the Quit India movement and many prominent leaders emerged during this time. These leaders made sure that the movement did not suffer due to the arrest of the prominent political leaders.
- The movement was not able to drag the British out of the India but paved the path for their demise in India.

OR

- (b) Gandhi's role in the Indian freedom struggle from 1922 till 1931:
- (i) In Jallianwala Bagh Massacre, more than 400 people were killed.
- (ii) Gandhiji planned that by combining Non-Cooperation with Khilafat, India's two major religious groups Hindus and Muslims could collectively bring an end to colonial rule.
- (iii) Students stopped going to schools and colleges run by the Government, lawyers refused to attend court. The working class went on strike in many towns and cities. As a politician, he transformed Indian National Movement into a broad Mass Movement. Through a unique method of non-violence, he won civic rights and eventually Independence for India's people. Due to this, he was followed by a number of people in his campaign for swaraj or 'Home rule'.

- (iv) A wave of awakening and fearlessness went through the public: This movement made the public fearless. They became mentally prepared to bear the punishment and the tyranny of the British rulers.
- (v) It transformed the national movement into a mass – movement: Under the Non-Cooperation movement, Gandhiji went from village to village awakening the villagers that British government cannot function without their cooperation. The villagers realized their strength and importance.
- (vi) Hilly tribes in Northern Andhra violated against the forest laws, farmers in Awadh did not pay taxes and peasants in Kumaun refused to carry loads to the British officials.
- (vii) On 12th March 1930, Gandhiji began walking from his ashram at Sabarmati towards the sea. He reached his destination after 3 weeks, making a fistful of salt and making himself a criminal in the eyes of the law.
- (viii) More parallel salt marches were conducted in other parts of the country. The Salt March was highly successful. It was the first Nationalist Movement in which women participated in large numbers. It was the Salt March which forced the British to realise that their Raj would not last forever and that they have to devolve some powers to the Indians. (1×8=8)

- **31.1** The text had represented Punna as an individual who did not believed in performance of rituals for gaining the purity from the sins committed.
- 31.2 Punna can be called as an awakened soul due to her idea of rational thinking which she has shown during her conversation with the Brahmin. - **31.3** Some of the teachings of Buddha evident here are:
 - (i) Do not believe in superstitious and analyse everything on the grounds of rationality.
 - (ii) Buddha was also against the performance of the rituals which was a major part of Hinduism.
- **32.1** Sultan of Morocco was elated by the travelling experiences of Ibn Batuta and wanted to preserve his experiences in written form for the future


- generations. Ibn Juzayy was a great literary scholar and would have documented the experiences of Ibn Batuta very appropriately.

SECTION - B

- **22.** Mahabharata is a colossal epic to understand the social behaviour of early historic period:
 - (i) It has explained about the existence of the institutions of families. The families used to share all the resources together like food and wealth.
 - (ii) It also laid down the rules of patriliny. The eldest son had the right to inherit the throne after the death of his father.
 - (iii) There was also a depiction of the rules of marriage. There were two types of marriage: exogamy and endogamy.
 - (iv) It was also believed that the Gotra of the women should be different from the family in which she was married.

- (v) This epic also contains different sections laying down norms of behaviours for different groups. (Any Three) (1×3=3)
- **25.** The role of the village panchayats in the rural Mughal society are:
 - (i) The village panchayats had a prominent position in every village and is a body consisting of the elders of the village.
 - (ii) This body was headed by an individual known as the Muqaddam who was elected by the consensus of the zamindars and the elders of the villages.
 - (iii) There were several functions that was taken care by the village panchayats like maintenance of land resources, maintaining the data for the village accounts, and other economic and political work.

- (iv) Activities like digging canal, arrangements for the cultural and religious activities were also taken care by this body.
- (v) They had the power to maintain law and order and can also levy fines for non-adherence to laws.(Any Three) (1×3=3)

- 29. (a) Bhakti movement in the south was led by Alvars:
 - (i) Nayanars and Alvars belonged to the 7th and 8th centuries. They all belonged to the different caste background. They were against the system of caste in society. They challenged the caste system and social inequalities that were prevalent in Indian society at the time.
 - (ii) The Bhakti movement received the great support from the state. The Pallava and the Chola dynasties provided the financial as well as the political support to the movements.
 - (iii) This movement was seen as a great measure to end the ritual supremacy of the Hinduism and make room for the generation of new sets of beliefs about worship of God.
 - (iv) It led to the creation of new forms of worship of God and showing the devotion. It led to the use of kirtans, poetry and several forms of dances for showing devotion to the God.
 - (v) The position of the women was also improved as some of the famous women saints like Andal and Laldyad made the Bhakti movement popular.
 - (vi) The state gave its support to the Bhakti movement as it led to the religious, social as well as the political transformation of the society.
 - (vii) The movement laid emphasis on the idea of equality. It ended the distinctions in the society on the basis of caste, creed and religion. Practices like Sati was also opposed.
 - (viii) This movement was a major step towards the establishment of an egalitarian society with no discrimination. (1×8=8)

OR

- **(b)** Guru Nanak's vision for the sacred world was all inclusive. Some of its ideals were:
- (i) Guru Nanak taught that there is one God who dwells within the human heart and can be known by the grace of the guru.
- (ii) Guru Nanak espoused a vision of equality across caste and religion, and he called for Sikhs to be fully socially engaged.
- (iii) Guru Nanak emphasized the "formless" God, spoken of as Nirankar. God may be spoken of

- in many ways—as Allah or Brahman, Ram or Rahim. But the great name of God is Truth.
- (iv) God cannot be known in any image or form; the Nirankar is invisible, infinite, beyond the confines of form.
- (v) He taught that all people, whether rich or poor, women or men, kings or peasants, can approach God equally.
- (vi) Guru Nanak's message of inclusiveness and universalism continues to be a central tenet of the Sikh faith.
- (vii) Sikhism is open to people of all backgrounds and beliefs, and the Sikh community actively promotes interfaith dialogue and understanding.
- (viii) For his teachings and beliefs, Guru Nanak is revered in very high standards by the people of all faiths. His idea was to spread love and devotion among the people. (1×8=8)
- **30. (a) Causes of Salt Satyagraha:** It was a nonviolent protest which was led by Mahatma Gandhi. There were several factors that led to the beginning of this movement.
 - (i) The British used to put tax on the sale and manufacturing of salt. This was seen as unreasonable and oppressive by the Gandhiji and he decided to launch a mass movement on the foundation of violation of the salt law. Due to this he started the famous Dandi March.
 - (ii) It started on 12th March 1930 to 6th April 1930.
 - (iii) The protest led by Mahatma Gandhi aimed to make salt tax-free in India. (Any Two)

The events associated with the salt satyagraha are:

- (i) On 12th March 1930, he lead a group of people from Sabarmati Ashram. He decided to walk through the villages of Gujarat.
- (ii) When the group of people reached the coastal village of Dandi on 6th April 1930, Gandhi made salt from seawater breaking the Salt Act imposed by the government.
- (iii) Throughout the protest the people were strictly instructed to not get involved in any kind of violence
- (iv) The British colonial government responded with brutal repression, arresting over 60,000 people, including Gandhi himself.
- (v) Despite the government's crackdown, it helped to galvanize support for independence both within India and around the world.
- (vi) The breaking of the salt law led to the beginning of the Civil Disobedience Movement in India.

SECTION - B

- **22.** A very ambitious project was started in 1919 CE under the leadership of noted Sanskrit scholar V.S. Sukthankar. Many scholars collectively decided to prepare a critical edition of Mahabharata:
 - (i) Initially, Sanskrit manuscripts of the epic, written in different scripts and in different parts of the country, were collected.
 - (ii) This team, comprising of scholars, worked out a method of comparing verses from each manuscript.
 - (iii) They selected all those verses which appeared common in all manuscripts. They published all these in several volumes running into 13,000 pages.
 - Around 47 years were taken to complete this project. $(1\times3=3)$
- **25. (i)** The major sources for the agrarian history of the 16th and early 17th centuries are chronicles and documents from the Mughal court.
 - (ii) One of the most important chronicles was the Ain-i Akbari authored by Akbar's court historian Abu'l Fazl.
 - (iii) Apart from the Mughal chronicles there are several official documents and travellers accounts which have provided great insights about the Mughal history in India. (1×3=3)

- **29.** (a) In the early centuries of Islam a group of religious minded people called Sufis turned to asceticism and mysticism in protest of the Caliphate against the growing materialism.
 - (i) The sufis sought on interpretation of the Quran through personal experiences.
 - (ii) They emphasized on seeking salvation through intense devotion and love for God.
 - (iii) The Sufis began to organize communities around the hospice or khanqah controlled by a teaching master known as sheikh.
 - (iv) The Khanqah took to mendicacy and observed celibacy. They ignored rituals and followed asceticism. They were known by different names like Qalandars, Malangs, Madaris, Haidaris, etc.
 - (v) When the sheikh died, he was buried in a tomb shrine and his tomb-shrine is was because called dargah.
 - (vi) It became the center of devotion for his followers. This encouraged the practice of

- pilgrimage or ziyarat to his grave, particularly on his birth, death and marriage anniversaries. This people believed that in death, saints were united with God.
- (vii) The Sufis were against the performance of any sort of rituals and gave the idea that love and devotion are enough to reach near the God.
- (viii) Sufis did not discriminated anyone on the basis of their religion, caste, creed and maintained the idea of equality in the society. Due to this their popularity increased significantly in the society.

- **(b) (i)** Mirabai is the best-known woman poet within the bhakti tradition.
 - (ii) She became a follower of Ravidas, a saint who was said to be untouchable. Meerabai's teachings are as follows:
 - (iii) She did not believe in the caste hierarchy and instead attacked higher caste standards.

- **(b)** The causes and events that led to the beginning of the Non-Cooperation movement are:
- (i) Rowlatt Act: In 1919, the Rowlatt Act also known as 'Black Act' was passed against the wish of all Indian members of the Legislative Assembly. This act authorised the Government to imprison any person without trial & convict him in a court.
- (ii) Jallianwala Bagh Massacre: To protest against the unlawful arrest of national leaders at a public meeting held in Amritsar culminated in what was known as Jallianwala Bagh Massacre in April 1919. Innocent men, women and children were killed and many more injured. The monstrous act provoked unprecedented indignation throughout the country.
- (iii) Khilafat Movement: The Khilafat Movement was launched by the Ali Brothers, Shaukat

Ali and Muhammad Ali to protest against the dismemberment of the Turkish empire and to restore Turkish Sultan as the spiritual head or Caliph of the Muslims. Gandhiji coupled the Non-Cooperation Movement with the Khilafat Movement. All these events led to the launching of the nationwide Non-Cooperation movement.

- **(iv)** During the movement people were asked to boycott foreign goods and institutions.
- (v) Thousands of children left schools and colleges, lawyers gave up their practice to join the movement. Foreign cloths were burnt in huge bonfires.
- (vi) The movement became popular among all sections of the society and saw great unity between Hindus and Muslims.
- (vii) The British administration was baffled for the first time from the movement since the revolt of 1857.
- (vii) However, During a clash between the police and movement protesters in Chauri Chaura, Uttar Pradesh, a violent crowd set fire to a police station, killing 22 police officers in February 1922. After this incident Mahatma Gandhi decided to put an end to the Non Cooperation Campaign. (1×8=8)

 - (iii) Elephants, an important component of the army, were found in forests in the region.
 - **(iv)** The Ganga and its tributaries additionally offered an inexpensive and practical method of communication.
 - (v) Early Buddhist and Jaina authors who wrote about Magadha attributedattributed its power to the policies of individuals, ruthlessly ambitious kings of whom Bimbisara, Ajatashatru and Mahapadma Nanda are the best known, and their minister, who helped implement their policies.
 - (vi) The two capitals, i.e. Rajagriha (Rajgir) and Pataliputra (Patna) of Magadha had their own advantages. Rajagaha was a fortified settlement, located amongst hill, thus, was not easily captured. Pataliputra was easily communicable through the Ganga and its tributaries. (Any Three) (1×3=3)
 - **(b)** The medieval era saw the emergence of urban centers for a variety of causes:
 - (i) With the discovery of iron, clearing forests was made incredibly simple. They started cultivating additional land since the use of iron made the field clear. They gained knowledge of the technique for growing two to three harvests per year. In the sixth century BC, this prompted urbanization.
 - (ii) At the administrative towns or power centers where the monarch and his officers resided, they might occasionally appear. The urbanization process also included temple towns. A large number of non-agricultural occupations were supported by them. Similar to this, port cities and commercial hubs helped craftspeople and traders.

- (iii) These facilities included those in Vaishali, Shravasti, Champa, Rajagriha, Kausambi, and Kashi
- **23.** The Mahabharata is considered as a dynamic text because:
 - (i) The stories and message of Mahabharata spread in many places and several languages.
 - (ii) Several region-specific stories found their way into the epic, but the central story remains the same.
 - (iii) Themes and episodes from the Mahabharata were depicted in sculpture, paintings, performing arts (dance, drama) and other kinds of narrations. (1×3=3)
- **24.** Ibn Battuta, a Moroccan traveler travelled and explored for 30 years, visiting over 44 nations, including India. The book "Rihla" contains his travel journal entries:
 - (i) Ibn Battuta speaks of the Indian rhinoceros that inhabited the Indus River's banks when he first arrived in Sindh.
 - (ii) He recorded about unique things (paan and coconut) and also compared coconut tree with that of palm tree, they look exactly the same except one produces dates and the other bears coconut as its fruit.
 - (iii) He also mentioned that the nut of the coconut tree resembles a man's head.
 - **(iv)** He described the paan as a tree which is cultivated in the same manner as the grapevine.
 - (v) Ibn Battuta found the cities in the subcontinent full of exciting opportunities and they were densely populated and prosperous.
 - (vi) He described Delhi as a vast city with huge population and equivalent to Daulatabad in size.
 - (vii) Most cities had crowded streets, bright and colourful markets with wide variety of goods. The bazaars were not only places of economic transactions, but the hub of social and cultural activities.
 - (viii) Most bazaars had a mosque and a temple. Space was marked for public performances by singers, dancers and musicians.
 - **(ix)** He found Indian agriculture very productive because of the fertility of the soil.
 - (x) Ibn Battuta was amazed by the efficiency of postal system which allowed merchants, to not only send information and remit credit across long distances but also dispatch goods.

25. (a) Virupaksha temple was significant in Vijayanagara empire. This can be proved by the following:

- (i) Lord Shiva, the god of protection, was the focus of the Virupaksha Temple, an ancient shrine.

- (iii) Krishnadeva Raya constructed the hall in front of the primary temple to commemorate his accession.
- (iv) Elegantly carved pillars served as the decoration.
- (v) Indicating the existence of the temple were gopurams, or regal entrances, which frequently dwarfed the towers on the central shrines.
- (vi) Kings and queens of the Vijayanagara dynasty reigned on behalf of Lord Virupaksha.
- (vii) Sri Virupaksha's name was used to sign orders.
- (viii) The title "Hindu Suratrana" used by rulers denoted close ties to God.
- (ix) Also on exhibit in temples were sculptures of royal portraits.
- (x) It was a significant event when kings and Amaranayakas visited temples.

 - (ii) They made an effort to unravel the enigmas of life and the connection between people and the cosmos. In the Ganga Valley, new kingdoms were just beginning to emerge at this period.
 - (iii) These thinkers were all attempting to comprehend these events.
 - (iv) Economic and social conditions were shifting.
 - (v) Cities and the new kingdoms were growing.
 - (vi) The Upanishads contain a lot of novel concepts, such as the concept of reincarnation, life after death, and the meaning of life.
 - (vii) The growth of goddess cults, Vaishnavism, Shaivism, and Mahayana Buddhism.
 - (viii) Changes were also occurring in socioeconomic life. (1×8=8)

- **(b)** One of the most significant stupas in India is the Sanchi stupa, which was constructed in the second century BCE.
- (i) According to art historians, the incident portrayed in the gateways is an excerpt from the Vessantara Jataka. By contrasting sculpture with literary data, they frequently attempt to decipher its significance.
- (ii) The Sanchi stupa employed a variety of symbols to represent the various Buddhist teachings, including an empty seat, a wheel, and a tree. For example, the empty seat was intended to symbolize the Mahaparinibbana.
- (iii) Buddha's first sermon was symbolized by the wheel.
- (iv) Perhaps not directly, other sculptures at Sanchi also drew their inspiration from Buddhism.
- (v) Beautiful women were depicted in the statues swinging from the edge of the entrance while

- clinging onto a tree, just like Shalabhanjika, a woman whose touch caused trees to bloom and yield fruit.
- (vi) In Sanchi stupa, other images such as; elephants, horses, monkeys, cattle, and other animals were also shown. Elephants were utilized as emblems for power and wisdom, while other animals were used to represent various human qualities.
- (vii) An image of a woman surrounded by lotuses and elephants that appears to be undertaking an Abhisheka or consecration is seen on the Sanchi stupa.
- (viii) Some historians believe it to be Maya, the mother of Buddha, while others associate her with the Hindu goddess Gajalakshmi (Goddess of good fortune). (1×8=8)
- 29. (a) The philosophy and teachings of Kabir are:
 - (i) Kabir Das had faith in an abstract deity. Many individuals from many groups adopted his beliefs.
 - (ii) Kabir described God as nirankar (having no shape). He used the terms drawn from Islamic tradition like Allah, Khuda, Hajrat and Peer but also used words of Vedic traditions like Alakh ((the unseen) and nirakar (the formless). Thus, he freely took to both traditions viz. Islamic and Vedantic.
 - (iii) He repudiated idol worship and polytheism.
 - (iv) He emphasised on the oneness of God though there can be many names of His.
 - (v) He criticised religious rituals of hindus and muslims alike.
 - (vi) He combined the Sufi traditions of love of God with the Hindi tradition of remembrance of God.
 - (vii) He also emphasised the dignity of labour.
 - (viii) He opposed the caste system and did not support it. His poetry was written in spoken Hindi, which made it simple for regular people to grasp. Both Muslims and Hindus are among his devotees.

- **(b)** The teachings and philosophy of Islam are:
- (i) Muhammad is the Apostle of Allah, who is the only all-powerful deity.

- **30. (a) (i)** The Civil Disobedience Movement was the first international movement, as all others had been confined to urban areas. Mahatma Gandhi had long been considering organizing a large-scale protest akin to the Civil Disobedience Campaign.
 - (ii) The movement's credo was nonviolence. This movement endured despite ongoing British repression.
 - (iii) Beginning on March 12, 1930, the Dandi March travelled 390 kilometers from Gujarat's Sabarmati Ashram to the coastal village of Dandi. Gandhi started walking to Dandi with 78 of his disciples.
 - (iv) Following Gandhi's detention, there were sizable demonstrations in Bombay, Delhi, Calcutta, and Sholapur, where the backlash was particularly virulent.
 - (v) Sarojini Naidu and Manilal Gandhi led the Salt Satyagraha in the Dharasana Salt Works, while C. Rajagopalachari and K. Kelappan led it in Tamil Nadu (Gujarat).
 - (vi) The Gandhi-Irwin Accord was signed on March 5, 1931 by Lord Irwin, India's viceroy at the time. The Gandhi-Irwin Accord, commonly referred to as the Delhi Pact, established parity between the Congress and the administration.
 - (vii) In 1934, the movement ceased to exist. Congress passed a significant measure in 1934. It called for the establishment of a constituent assembly that would be chosen by the general populace utilizing the adult franchise.
 - (viii) Despite not succeeding in its objective, the Congress was successful in organizing sizable portions of the populace for the nation's second major popular uprising. It had also outlined ambitious objectives for changing Indian society. (1×8=8)

(b) Gandhi's transformation of Indian nationalism:

After leaving South Africa, Gandhiji, at Gokhale's recommendation, spent a year traveling throughout British India and getting to know the country's people. With the founding of the Banaras Hindu University (BHU) in February 1916, he made his first significant public appearance. An time for joy, the BHU's launch marked the start of a nationalist institution supported by Indian funding and effort. Gandhiji, however, opted to remind the audience of the peasants and labourers who made up the majority of the Indian population rather than adopting a tone of self-congratulation.

Gandhiji at Champaran (Bihar): Gandhiji was given the chance to put his teachings into action in the latter month of that year. A peasant from Champaran in Bihar approached him at the annual Congress, which was convened in Lucknow in December 1916, and informed him of the severe treatment that British indigo planters had meted out to peasants there. In order to secure tenure security and the freedom for the peasants to grow the crops of their choosing, Mahatma Gandhi spent a significant portion of 1917 in Champaran.

In his native Gujarat, Gandhiji participated in two campaigns the following year, 1918. Initially, he got involved in an Ahmedabad labor dispute and demanded improved working conditions for the mill workers. Gandhiji later joined farmers in Kheda as they petitioned the government for a tax exemption after their harvest failed. Gandhiji became known as a nationalist with a strong concern for the underprivileged thanks to his initiatives in Champaran, Ahmedabad, and Kheda.

Gandhiji later demanded that a campaign against the "Rowlatt Act" be launched in the countryside. Even when key local Congressmen were taken, Gandhiji was detained as he traveled to Punjab. A British General gave his forces the order to open fire on a nationalist gathering in Amritsar in April 1919, which precipitated a deadly escalation of the province's delicate situation. The Jallianwalan Bagh Massacre, also known as, claimed the lives of more than 400 individuals. Gandhiji became a true national leader as a result of the Rowlatt Satyagraha. Gandhiji urged a campaign of "non-cooperation" with British power, inspired by its accomplishment. Indians who desired the end of colonialism were advised to avoid attending schools, colleges, and courts as well as not paying taxes. Whole "renunciation of (all) voluntary affiliation with the (British) Government" was requested of them. Gandhiji therefore inspired the Indian people to engage in a furious conflict with the British.

- **31.1** Archaeologists classify the findings according to their intended uses. They further categorize according to the materials employed, with igneous rock or sandstone generally displaying traces of heavy use.
- 31.2 Archaeologists utilize comparisons from modern life to comprehend ancient artifacts. They judge them based on how much they resemble contemporary objects like pots, beads, querns, and stone swords. the environment in which it was found, such as a house, a drain, a burial, a kiln, etc.

- 31.3 Saddle Querns are plentiful and appear to have been the only method of grinding grains, according to Ernest Mackay, who noted their use. The majority of the wear and tear on them is due to their rough construction from igneous rock or sandstone. To keep them from wobbling, their bases were designed convex to set in the ground or dirt. (4)
- **32.1** Due to the fact that the primary goal of agriculture was to feed people, there was an abundance of land, a labour pool, and the mobility of peasants, which were all key factors in the ongoing expansion of the agricultural sector in mughal period.
- **32.2** The Mughals had installed irrigation systems in a variety of locations. People in the Lahore region used to pump water using wheels. People in Agra, Chandwar, and Bayana used to irrigate their fields with buckets and bulls.
- 32.3 The storage of well water, surface water, and rainwater allowed for the development of a sophisticated irrigation system in Mughal India. Water from these sources was collected in tanks and then channelled through an extensive system of canals to supply the huge agricultural areas. The stored water was also used, as well as some water-lifting equipment. The primary water sources

- for this irrigation were wells and tanks. Various machinery was employed to transfer water from wells into field canals. The lever-operated wooden scoop, known as a dhenkl, was the most basic tool and could be used where the water was close to the surface.

- **33.1** In North Bengal, Jotedars rebelled against the Zamindars of Dinajpur because they had disciplined them and reduced their authority.
- **33.2** The Jotedars rallied the village's ryots, who were reliant on them. They provoked the tiny ryots to withhold their revenue as a result the Jotedars purposefully put off paying revenue to the Zamindars.
- 33.3 The group of wealthy peasants was strengthening their power in the villages known as jotedars while a great number of zamindars were going through a crisis at the end of the 18th century (during the British East India Company). The jotedars, or affluent class peasants, had accumulated huge tracts of land by the early 19th century—sometimes as much as several thousand acres. Share-croppers who brought their own ploughs, worked in the field, and gave the jotedars half of the harvest were responsible for cultivating a sizable portion of the jotedars' property. (4)
