Surajendu Kumar's study on the effect of the modernization of a Government Printing Press on Press maintenance work and workers is a solid contribution to a debate that encompasses two lively issues in the history and sociology of technology: technological determinism and social constructivism.

Kumar makes the point that the characteristics of a technology have a decisive influence on job skills and work organization. Put more strongly, technology can be a primary determinant of social and managerial organization. Kumar believes this possibility has been obscured by the recent sociological fashion, exemplified by Cravman's analysis, that emphasizes the way machinery reflects social choices. For Cravman, the shape of a technological system is subordinate to the manager's desire to wrest control of the labour process from the workers. Technological change is construed as the outcome of negotiations among interested parties who seek to incorporate their own interests into the design and configuration of the machinery. This position represents the new mainstream called the social constructivism.

The constructivists gain acceptance by misrepresenting technological determinism: technological determinists **are supposed to** believe, for example, that machinery imposes appropriate forms of order on society. The alternative to constructivism, in other words, is to view technology as existing **outside** society, capable of directly influencing skills and work organization.

Kumar refutes the extremes of the constructivists by both theoretical and empirical arguments. Theoretically, he defines "technology" in terms of relationship between social and technical variables. Attempts to reduce the meaning of technology to cold, hard metal are bound to fail, for machinery is just scrap unless it is organized functionally and supported by appropriate systems of operation and maintenance. At the empirical level, Kumar shows how a change at the Printing Press from maintenance-intensive electromechanical devices to semi-electronic devices altered work tasks, skills, training opportunities, administration, and organization of workers. Some changes Kumar attributes to the particular way management and labour unions negotiated the introduction of the technology, whereas others are seen as arising from the capabilities and nature of the technology itself. Thus, Kumar helps answer the question: "When is social choice decisive and when are concrete characteristics of technology more important?"

SECTION - A: ENGLISH

1. Option (b) is correct.

The passage is about Kumar's study as a solid contribution to technological determinism and social constructivism. Technological determinism believes that the features of technology govern the structure of the organisation. And social constructivism believes that technology reflects social choices. The last paragraph states, 'Kumar refutes the extremes of the constructivists...'. This makes it clear that Kumar challenges constructivist notions.

2. Option (d) is correct.

Refer to the lines of the passage, 'Surajendu **Ku**mar's study on the effect of the modernisation of a government printing press on press maintenance work and workers is a solid contribution...' and 'Kumar shows how a change at the printing press from maintenance-intensive electromechanical devices to semi-electronic devices altered work tasks, skills, training opportunities, administration, and organisation of workers'. From this, it can be deduced that Kumar's study focuses on the printing press and its impact on maintenance work and workers.

3. Option (c) is correct.

Refer to the lines: 'Kumar believes this possibility has been obscured by the recent sociological fashion, exemplified by Cravman's analysis, that emphasises the way machinery reflects social choices. For Cravman, the shape of a technological system is subordinate to the managers' desire to wrest control of the labour process from the workers. On the contrary, Kumar shows how a change at the printing press from maintenanceintensive electromechanical devices to semielectronic devices altered work tasks, skills, training opportunities, administration, and the organisation of workers. From the above statements, it is clear that Kumar and Cravman's views are contrary to each other, and Kumar does not support Cravman's thought.

4. Option (a) is correct.

'The constructivists gain acceptance by misrepresenting technological determinism...' and '... technology as existing outside society, capable of directly influencing skills and work organisation...' From this, we can deduce that constructivists view technological determinism as seeing technology as outside society, influencing workers' skills.

5. Option (c) is correct.

Refer to the line: "Technology can be a primary determinant of social and managerial organisation." Kumar believes the acceptance of technology as a primary determinant has been concealed.

6. Option (d) is correct.

Refer to the line, "The constructivists gain acceptance by misrepresenting technological determinism...' From this, we can infer statement (4). There is no discussion of any hypothetical situation, so, option (a) is eliminated. Empirical studies support Kumar's position; they do not support constructivists' positions, so, option (b) is also ruled out. option (c) is out of scope.

7. Option (c) is correct.

Refer to the lines, 'The constructivists gain acceptance by misrepresenting technological determinism: technological determinists are supposed to believe, for example, that machinery imposes appropriate forms of order on society.' The sentence makes it clear that determinists were supposed to believe something, with which the author apparently disagrees.

8. Option (b) is correct.

Refer to the lines: 'At the empirical level, Kumar shows how a change at the printing press from maintenance-intensive electromechanical devices to semi-electronic devices altered work tasks, skills, training opportunities, administration, and organisation of workers. Some changes Kumar attributes to the particular way management and labor unions negotiated the introduction of the technology, whereas others are seen as arising from the capabilities and nature of the technology itself." From these lines, we can deduce that Kumar's study of printing press was to examine the impact of technology upon workers and organisations. Hence, the correct answer is option (b). Option (a) can be ruled out because of the word "conflict." Option (c) is ruled out because there is no mention of the benefits of technology on management or labour in the passage. Option (d) can be ruled out because Kumar's study describes the depth of both views, in the process of which Kumar has put forth Cravman's views as being supportive of social constructivism.

9. Option (a) is correct.

This question tests a student's vocabulary. Loquacious means tending to talk a great deal; talkative. Example: "Never loquacious, Sarah was now totally lost for words." Hence, the correct answer is option (a). Taciturn means reserved or uncommunicative in speech; saying little. Example: "After such gatherings, she would be taciturn and morose." Laconic means (of a person, speech, or style of writing) using very few words. Example: "His laconic reply suggested a lack of interest in the topic."

10. Option (c) is correct.

This question tests a student's vocabulary. Precocious means having developed certain abilities or inclinations at an earlier age than is usual or expected. Example: "A precocious talent for computing."

11. Option (d) is correct.

Ineluctable means unable to be resisted or avoided; inescapable. Example: "The ineluctable facts of history." Hence, the correct synonym of "ineluctable" is unavoidable. Illusive means deceptive. Example: It had been like the stage gauze which gives an illusive air of reality to the painted scene behind it. Evitable means able to be avoided or prevented; avoidable. Example: "Unfortunately, complexity isn't always avoidable."

12. Option (b) is correct.

This question tests a student's understanding of grammar. The easiest sentence to identify the usage of "down" is (c). In (C), "down" is used as a preposition. There is only one option with the combination of 2-C, option (b).

13. Option (d) is correct.

This question tests a student's understanding of grammar. The easiest sentence to identify the

usage of "why" is (c). In (c), "why" is used as an interjection. There is only one option with the combination of 4-C, option (d).

14. Option (c) is correct.

The original sentence has multiple errors. The use of "consider" in the given sentence is incorrect, resulting in a modifier error. 'Consider' should be followed by 'what she was considered.' Also, "a better poet" is the correct usage. Sentences (a) and (d) are eliminated because of the incorrect use of the word "consider." Statement B is eliminated because it has a tense inconsistency. Statement (c) draws a clear contrast by using "although" at the beginning of the sentence, and it also rectifies the usage of "consider".

15. Option (d) is correct.

The sentence has an error of parallel construction. In sentence (a) the correct parallelism should be 'by its eastward orientation, by its overall plan, as well as by artifacts. Sentence (b), distorts the sentence's meaning. Sentence (c) again changes the meaning of the sentence by saying "as indicates its eastward orientation." Sentence (d) uses the correct parallel structure; hence, it is the correct answer.

16. Option (b) is correct.

In the non-underlined portion, we have the phrase "Octopus... have a strong regenerative capacity..." So "octopus" is definitely plural, at least in the beginning of the sentence. In the underlined portion, the first "it" refers to "the octopus" and the second "it" refers to the arm. The usage of the first "it" is definitely incorrect since, its antecedent is a plural noun. Hence, sentence A is ruled out. In sentence (b) the word "arm" is the closest potential referent to "it", so it is grammatically correct here: "... if one arm is lost, [the arm] is quickly replaced..." Hence, (b) is the correct answer. In the sentence (c) the use of "by the animal overcompensating" is incorrect. The phrase "by the animal overcompensating" suggests that the overcompensation is how the starfish replaces its arm. Hence, it is ruled out. In sentence (d), the use of the pronoun "they" is ambiguous. Hence, it is also ruled out.

17. Option (c) is correct.

The sentence makes an incorrect comparison. The eyes of the catfish should be compared with the eyes of other animals. The correct rephrasing should be "than do those of any other animal." Hence, sentence (a) is ruled out. In sentence (b) there is an error of subject-verb agreement. Rather "than do those of any other animal. It says "than those of any other animal." Hence, sentence (b) is ruled out. Sentence (d) has a pronoun error, as the pronoun "it" lacks a clear referent. It also incorrectly refers to the singular noun "the elephant seal" with the plural pronoun "them". Sentence (c) correctly refers to the singular noun "the elephant seal" with the singular pronoun "it". Further, Option (c) correctly compares "the eyes of the elephant seal" to "those of any other animal".

18. Option (d) is correct.

Sentences (a) and (c) are easily eliminated because they have errors in subject-verb agreement. The singular subject "yields" is used for the plural subject "trenches." In statement (b), "having been cut" is awkwardly wordy. This error is rectified in the statement (d).

19. Option (b) is correct.

In sentences (a) and (c) ("...the fixed costs... *makes* it more expensive..."), there is a clear subject-verb agreement error.

In sentence (b) the pronoun "they" correctly refers to the nearest plural, "nuclear plants." And that works just fine: "The fixed costs that stem from building nuclear plants make the electricity [nuclear plants] generate more expensive."

In sentence (d), there is a lot of ambiguity.

20. Option (b) is correct.

In sentences (a) (c) and (d) there are errors of parallelism. In sentence B, this error is rectified: "that gives mouth sores to cattle and displaces grasses..." now clearly modifies "a herbaceous plant from Eurasia."

21. Option (c) is correct.

In sentence (a) there is an error of subject-verb agreement: "struggles that limits." Sentences (b) and (d) are awkward and needlessly wordy due to their use of the word "being," which also alters the meaning of the sentences. Sentence (c) correctly equates the plural verb "struggles" with the plural verb "limit". Also, it uses the clause "the ants consider all their fellows to be close relatives", conveying the intended meaning: that all individual ants consider all their fellows to be individual close relations.

22. Option (a) is correct.

The original sentence is grammatically correct. Thus, no change is required. Hence, the correct answer is option (a). Sentence (b) uses 'more' repeatedly, thereby making the subject of the clause vague. Sentence (c) has a structure that makes reading stressful and has an omitted prepositional phrase, '900,000 artisans worked'. Sentence (d) has a mismatched structure that emphasizes the details of the elements used in the making of the army in a distributed manner.

23. Option (b) is correct.

The given sentence draws comparisons between the tides in different regions. The correct form of comparative should be 'some places' and 'others' because some already shows a fraction of the whole or the rest. Sentence A is awkward because of the use of "that," which gives a sense of incompleteness. Sentence (b) makes an apt comparison.

24. Option (a) is correct.

An epigram is a concise, clever, and sometimes paradoxical statement or line of verse. Example: "If we don't end the war, the war will end us." – G. Wells

Statement (a) is an example of an oxymoron. Oxymoron is a figure of speech that pairs two words together that are opposing and/or contradictory. Example: And faith in the unfaithful kept him falsely true. Here, it is simple and cunning.

25. Option (a) is correct.

Litotes is an ironic understatement in which an affirmative is expressed by the negative of its contrary. Example: That compliment is not unwelcome.

In the given sentence, "no mean" is a phrase that denotes something very good of its kind. Hence, statement (a) is an example of litotes.

26. Option (d) is correct.

A metaphor is a figure of speech that makes a comparison between two non-similar things. As a literary device, metaphor creates implicit comparisons without the explicit use of "like" or "as." Example: He has a heart of gold. In this context, the words "revenge" and "justice" cannot be used interchangeably.

27. Option (b) is correct.

Metonymy is a figure of speech (or trope) in which one word or phrase is substituted for another with which it's closely associated (such as "crown" for "royalty"). Example: The White House will be making an announcement around noon. In the given question, "he was playing the gallery." is an example of metonymy. It tries to convey that he was performing for the audience in the gallery. The rest of the sentences are examples of synecdoche.

28. Option (c) is correct.

Oxymoron is a figure of speech that pairs two words together that are opposing and/or contradictory. Example: And faith in the unfaithful kept him falsely true. The phrase "kind cruelty of the surgeon's knife" is contradictory in the given question.

29. Option (b) is correct.

Puns are figures of speech that rely on a form of word play, whereas jokes are narrative structures intended to create humour and laughter. Example: A pessimist's blood type is always B-negative. In the given question, the second statement is an example of a pun, which says the ambassador is an honest man who lies.

30. Option (d) is correct.

The passage says that late payment of the rent by a tenant will result in the landlord bearing some cost. The right word for this is "incur".

31. Option (c) is correct.

According to the passage, a tenant's late rent payment will cost the landlord some money. The passage further states that this cost will be difficult to calculate because it is neither mentioned in the lease nor can be easily calculated. The blank in the word should mean 'to find out or say for sure.' The word is ascertained.

32. Option (b) is correct.

The previous sentence says that the cost will be difficult to calculate. This sentence defines that this cost will be inclusive of the components mentioned further. The use of 'but' introduces a phrase or clause contrasting with what has already been mentioned. This indicates that, apart from the components mentioned further, there can be additional components as well. This means that the things named are part of something larger, and the larger thing may also have other parts. Hence, not limited will be the correct word.

33. Option (a) is correct.

Dictate means to state or order and is more commonly used with orders or policies. Oblige means to compel or bind someone; it can't be followed by the preposition 'on'. 'Required on' is grammatically incorrect; hence, three of them can be eliminated. The only word that goes with "on landlord" is imposed. Charges are imposed or levied.

34. Option (c) is correct.

With time periods, the word "due" should be used. Late payment means the amount was not paid on the agreed date or time.

35. Option (b) is correct.

Rights and remedies are not practiced, commanded, or undertaken. Rights and remedies can be exercised.

SECTION – B: GENERAL KNOWLEDGE AND CURRENT AFFAIRS

36. Option (a) is correct.

North-western India gets rainfall in the winter season of January and February due to western disturbance in the Mediterranean Sea. According to the India Meteorological Department (IMD), western disturbances are the storms that originate in the Mediterranean Sea and bring nonmonsoonal rainfall in the north-western parts of India. A western disturbance is an area of low pressure which is responsible for sudden showers, snow and fog in the north-western parts of India.

37. Option (d) is correct.

Option 'd' is the most appropriate because statements I, II and III are correct regarding the methanol-based economy. 











102. Option (b) is correct.

The argument of the politicians is that because of the devaluation of the country's currency, foreign investors are benefiting and are able to get the units for less than what their value should have been. But if the value of any unit is determined by the profit gained by that unit, the value of those units as determined by the profit must have been reduced because the devaluation of the currency would have impacted the profits negatively. This casts doubt on the politicians' argument.

103. Option (a) is correct.

The paragraph asserts that the proposed new safety rules will increase the minimum time between departures from ports. This will result in a decrease in the number of trips. As a result, fewer people are travelling. Since the city's operating budget mainly depends on the tax generated by tourist spending, the decreased number of trips will decrease the number of tourists and decrease tax revenue. Thus, the author is assuming that the new safety rule will not include the increase in the number of people per ship.

104. Option (d) is correct.

And thus, the conclusion that most employees of the company almost certainly work at least some overtime need not be true.

105. Option (c) is correct.

The paragraph concludes that the increased tax on luxury cars will increase government revenue.

The paragraph also mentions that 30 percent of the workers employed by the manufacturers of luxury cars have lost their jobs. It is a fact that the government will suffer a loss of revenue with the loss of jobs of workers. Nevertheless, the government still stands to gain from this recently introduced tax on sales of new luxury cars, only if the new tax revenue exceeds the loss (from the loss of jobs).
