How do I know that you have been getting yourself very wet lately, and that you have a most clumsy and careless servant girl?" "My dear Holmes," said I, "this is too much. It is true that I had a country walk on Thursday and came home in a dreadful mess, but as I have changed my clothes, I can't imagine how you deduce it. As to Mary Jane, she is incorrigible, but there, again, I fail to see how you work it out." "It is simplicity itself," said he; "my eyes tell me that on the inside of your left shoe, just where the firelight strikes it, the leather is scored by six almost parallel cuts. Obviously, they have been caused by someone who has very carelessly scared round the edges of the sole in order to remove crusted mud from it. Hence, you see, my double deduction that you had been out in vile weather, and that you had a particularly malignant boot-slitting specimen of the London slavery."

In fiction, detectives like Holmes are usually portrayed as people with exceptionally brilliant minds. They possess the rare skill to see and analyse what ordinary people can't. They have incredible abilities to infer, deduce, induce and conclude.

Then, there is G.K. Chesterton's fictional catholic priest, Father Brown who relies on his extra ordinary power of sympathy and empathy that enable him to imagine and feel as criminals do. He explains, "I had thought out exactly how a thing like that could be done, and in what style or state of mind a man could really do it. And when I was quite sure that I felt exactly like the murderer myself, of course I knew who he was."

Sherlock finds the criminal by starting from the outside. He relies on science, experimental methods and deduction. On the contrary, Father Brown uses varied psychological experiences learned from those who make confessions of crime to him. He relies on introspection, intuition and empathy.

There is yet another set of detectives like those created by writers like Agatha Christie. Her Belgian detective, Hercule Poirot is a story-teller who draws information from the stories that others tell. He patiently listens to numerous accounts of what happened, where it happened and how it happened. He listens for credibility and ambiguity; he identifies why and how the pieces of the jig-saws don't fit together. Ultimately, he uncovers the truth.

Since long, we have witnessed unimaginable levels of success and failure of various projects, businesses, scientific missions and even wars. From such triumphs and defeats emerges the much debatable thought: Are planning and strategy more important than execution?

Some project leaders and their teams are of the view that planning leads to clarity of objectives; it helps to set the timeline and the budget. Consequently, when the planning is haphazard and unstructured, the very aims of the projects become hazy. This further leads to unprecedented budget collapses and poor time-management. In some cases, teams have worked relentlessly to complete assignments, but poor planning has invariably led to customer dissatisfaction and at times a complete collapse of the entire project. In the words of Benjamin Franklin, "Failing to plan is planning to fail."

Numerous entrepreneurs have the faith that strategies help to enhance not only speed and quality of production, but also consumer satisfaction. If there are no strategies to tackle unplanned events or unexpected interruptions, there is a possibility of entire projects coming to a grinding halt.

Some of the world's best airports, bridges and astronomical missions are the result of careful planning and excellent strategies. However, there are some architects, artists and entrepreneurs who prefer to dive straight from the board of ideas into the pool of execution. They believe that suitable strategies are best shaped during the process of execution; great plans and strategies can fail while encountering unexpected situations.

Steve Jobs says, "To me, ideas are worth nothing unless executed. They are just a multiplier. Execution is worth millions."

According to Bill Gates, unhappy customers are the greatest source of learning. Fickle-minded consumers and wavering market trends can mar projects that stand on fixed plans. It is the need-based, flexible and innovative strategies that help to withstand the impact of these vacillating desires and trends.

After rigorous planning and testing a new recipe on two lakh consumers, in 1985, the company Coke brought out the New Coke. Much to the company's dismay, the product did not take off as expected and the financial loss was enormous. The company realized that during the process of data collection, it had not considered the product-loyalty and old-fashioned habits of the consumers.

Hence, a balance of pragmatic planning, effective strategies and efficient execution is likely to ensure the accomplishment of tasks at each stage of a project. Successful execution is not an easy journey. The road is winding and bumpy. It may require tweaking or at times abandoning the original plan and re-designing it.

Often, we turn to nature for inspiration. Think plans and strategies are the seed, execution is the nourishment, and consumer is the capricious weather.

Since the worldwide inoculation process is going strong, vaccine diplomacy has become a hot topic. In their quest for ensuring vaccine security, a report by *The New York Times*, based on the data on vaccine contracts compiled by Duke University, shows that the advance purchase contracts made by some advanced countries for potential vaccines would vaccinate their population many times: the European Union, two times, the United States and the United Kingdom, four times, and Canada, six times. The expectation that an early vaccination will bring back normalcy and a required push to economic growth fuelled many advanced countries to engage in vaccine battles. The arguments of public good and global cooperation have gone out of the window now. While advanced countries have turned their back on the need of poor countries to access COVID-19 vaccines, India has displayed empathy to their needs. India has taken a position that a significant percentage of the approved doses will be permitted for exports. While its export to neighbouring countries will be under grant mode, initial shipment of vaccines to least developed countries will be free of cost. Shipments of vaccines from India have already started reaching different parts of the developing world. While India is in its first phase of vaccination to cover healthcare workers, exports from India are helping other countries in initiating the phase one of their vaccination programmes, a gesture well appreciated globally. In a democracy, one can expect the backlash of sending vaccines abroad without vaccinating its own population. Nevertheless, India's approach only reinforces

the need of having coordinated global efforts in bringing COVID-19 under control. This response manifests India's unstinted commitment to global development and has consolidated its name as the world's pharmacy. The attitude of India towards vaccinating the populations in the poorer countries has generated discussion in the richer countries about the necessity for more proactive measures to roll out vaccines to the developing nations.

Following the transition to democracy, with the inauguration of Nelson Mandela as the president in 1994, South Africa was faced with the task of dealing with its past, as well as undertaking some actions to deal with structural social injustice. The Truth and Reconciliation Commission (TRC), heralded as the most ambitious and organised attempt to deal with crimes of a past regime through a concept of truth, came into force on 19th July, 1995 in South Africa. Emerging as a political strategy to acknowledge past sufferings whilst promoting a future based on the concerns of social justice, the rule of law and reconciliation, the Commission has struggled to fulfil its objectives. Although the TRC incorporated these broader concerns into the mandate of its three sub-committees, they were disregarded in practice. These sub-committees, which reflected concerns for 'human rights violations', 'amnesty' and 'reparation and rehabilitation', were not 'coupled with some form of social transformation'. The public transition from apartheid, established through a negotiated settlement rather than a revolutionary process, framed the Commission's powers. Shaped by the historical context of this particular transition, the TRC was careful not to 'rock the structural boat'. Rather than pursuing truth and justice, as an integrated feature of social transformation, the Commissioners and, to a greater extent, the government of South Africa, maintained an agenda that avoided a challenge to the status quo. A focus on restorative justice was taken by the Commission with an emphasis placed on mechanisms to restore victims and survivors, through reparations policy, state-led acknowledgement of suffering, and a condemnation, together with the transformation, of the system that implemented such widespread forms of abuse. The priority of changing the apartheid conditions of gross inequality and oppression provided a backdrop to the approval of the TRC by those who had suffered. More difficult to accept was the provision of amnesty to those who had undertaken violations of human rights. The process placed amnesty of violations as a carrot to perpetrators in exchange for a full story, with the stick of prosecutions for those who did not come forward.

In the domain of education, the current pandemic has made three things clear. It has proved beyond any doubt that we need schools. Irrespective of which country one talks about, students and parents want schools to open and function in full glory, with appropriate precautions. Secondly, it has shown that technology may prove to be useful in education if it is employed thoughtfully. Random surfing of the Internet may lead to a collection of pieces of information that do not add up to any meaning. As Noam Chomsky says, "You cannot pursue any kind of inquiry without a relatively clear framework that is directing your search and helping you choose what is significant and what is not." Moreover, there cannot be any hegemonic techno-managerial solutions to the linguistic and cultural heterogeneity of students; technology must help us to respect individual, peer group and community needs and aspirations. Thirdly, a convergence of the efforts of the public, civil society and private enterprises will have to take place if we wish technology to meaningfully mediate between school and home, particularly among underprivileged groups.

The concept, structure and functioning of a school/college should not be trivialised in any way. This institution has survived since ancient times in spite of proposals for "de-schooling" of various kinds. It is true that schools to a great extent perpetuate the status quo and, as Ivan Illich observed, encourage "consumerism" and "obedience to authority"; but it is also true that those who produced some of the most revolutionary moments in history, including quantum jumps in knowledge, also went to school. The kind of web of learners Illich imagines may in fact have its roots in schools. There are also people who trivialise schools for the kind of investments they demand in terms of space, buildings, teachers, libraries and labs and other infrastructure.

One thing you never forget is the school you went to, friends you made there and the kind of teachers who taught you; the kind of teachers you loved, the kind you mocked at with friends. You recollect nostalgically the sports and other cocurricular activities you took part in. Some of you may still have preserved your school blazer, trophies and photographs with a sense of joy. It is important to see school holistically; it is not a set of atomic items of rooms, library, assembly halls, canteen and playgrounds; it is all of these but in symbiotic relationship with each other, the contours of which are often far too obvious and often simply mysterious.

A new report forecasting that India can create millions of additional jobs over the coming years in the gig economy underscores a fundamental shift in the nature of work. While automation swept through factory floors and BPOs reduced manpower requirements; e-commerce, ride hailing and food delivery apps, streaming media and fintech have created lakhs of temporary jobs in the service sector. Although the jury is still out on the quality of life accorded by such gigs and the social security benefits they accord, recall that informalisation of jobs started much earlier. The report by Boston Consulting Group and Michael & Susan Dell Foundation predicts 90 million flexi and gig jobs in a decade from 8 million now, contributing transactions valued at more than \$250 billion and an additional 1.25% to India's GDP. Obviously, technological evolutions are hard to predict. A decade ago, few, if any, had divined these new jobs. Accepting change as the sole constant, it is equally critical to create the socio-economic framework that can support such jobs.

Expecting startups fuelled by venture capital and presently unprofitable to treat gig workers as regular employees isn't practical. Such moves could impede innovation and investment. But if central and state governments could deliver in areas like public health, education, insurance and food security, anxieties generated by unsteady, irregular unemployment can be managed better. Last year's nationwide lockdown when the suddenly unemployed migrant workers panicked and bolted, untrusting the promises of governments to care for them, served out this lesson in poignant detail. The gig economy does promise flexibility and improved choices for many women and part time workers. Every technological revolution till date has effaced some jobs and created plentiful others. There is room for optimism in the rapidly emerging techmediated world, but only upon strengthening the support of educational and health infrastructure.

There is really nothing new, not already anticipated in a distressed planet since the emergence of human species life nearly two million years ago. So, a long prehistory of inter-faith dialogue entailing the reciprocal relation between religious traditions and the robustness of the very idea of being human and having rights, precedes the recent UN movement of faith for rights (F4R). The F4R framework has finally been affirmed by the United Nations system. The Office of the High Commissioner for Human Rights (OCHR) promoted the Rabat plan of action in 2012. Note that this happened after the end of the Cold War, during globalisation, and soon after 9/11. The plan was a result of a series of expert workshops on the prohibition of incitement to national, racial or religious hatred, underlying "legislative patterns,

LEGAL REASONING

XIV.

Harm suffered voluntarily does not constitute a legal injury and is not actionable. This principle is embodied in the maxim *volenti non fit injuria*. A person cannot complain of harm to the chances of which he has exposed himself with his free consent and free will. The maxim *volenti non fit injuria* is founded on good sense and justice. A person who has invited or assented to an act being done towards him cannot, when he suffers from it, complain of it as a wrong. The maxim presupposes a tortious act by the defendant. The maxim applies, in the first place, to intentional acts which would otherwise be tortious. There are certain limitations to the application of this maxim:

- (i) It is no answer to a claim made by a workman against his employer for injury caused through a breach by the employer of a duty imposed upon him by a statute. But where the negligence or breach of statutory duty is on the part of an employee of the plaintiff who knowingly accepts the risk flowing from such breach and the employer-defendant is not guilty of negligence or breach of statutory duty, the defence of *volenti non fit injuria* is available to the defendant.
- (ii) Under an exigency caused by the defendant's wrongful misconduct, consciously and deliberately faced a risk, even of death, whether the person endangered is one to whom he owes a duty of protection, as a member of his family, or is a mere stranger to whom he owes no such special duty. The rescuer will not be deprived of his remedy merely because the risk which he runs is not the same as that run by the person whom he rescues. But where there is no need to take any risk, the person suffering harm in doing so cannot recover.
- (iii) To cover a case of negligence the defence on the basis of the maxim must be based on implied agreement whether amounting to contract or not. The defence is available only when the plaintiff freely and voluntarily, with full knowledge of the nature and extent of the risk impliedly agreed to incur it and to waive any claim for injury. But when the plaintiff has no choice or when the notice is given at a stage when it is beyond the ability of the plaintiff to make a choice there can be no implied agreement and the defence on the basis of the maxim must fail.

- (iv) The maxim will also not apply when the act relied upon is done because of the psychological condition which the defendant's breach of duty had induced.

It is essential to the creation of a contract that both parties should agree to the same thing in the same sense. Mutual consent, which should also be a free consent, is the sine qua non of a valid agreement and one of its essential elements is that a thing is understood in the same sense by a party as is understood by the other. Not only consent, but free consent is provided in Section 10 of the Indian Contract Act, 1872 to be necessary to the complete validity of a contract. Consent is free when it works without obstacles to impede its exercise. Where there is no consent or no real and certain object of consent, there can be no contract at all. Where there is consent, but not free consent, there is generally a contract voidable at the option of the party whose consent was not free. A general averment that consent was not freely obtained is not enough, and it is necessary to set up one of the vitiating elements such as fraud which includes, false assertion, active concealment, promise without intention of performing it, any other deceptive act, or any act declared as fraudulent. In order to constitute fraud, the act should have been done by the party to the contract, or by any other person with his connivance, or by his agent and with intent to deceive the other party thereto or his agent, or to induce him to enter into the contract. There is no duty upon parties to speak about facts likely to affect the other party's consent to the contract and mere silence does not amount to fraud, unless the circumstances of the case show that there is duty to speak, or silence is, in itself equivalent to speech. On the other hand, misrepresentation falls into three categories: (i) a statement of fact, which if false, would be misrepresentation if the maker believes it to be true, but which is not justified by the information he possesses; (ii) any breach of duty which gains an advantage to the person committing it by misleading another to his prejudice, there being no intention to deceive; and (iii) causing a party to an agreement to make a mistake as to the substance of the thing which is the subject of the agreement, even though done innocently.

Communication when complete - The communication of a proposal is complete when it comes to the knowledge of the person to whom it is made.

The communication of an acceptance is complete, - as against the proposer, when it is put in a course of transmission to him so as to be out of the power of the acceptor; as against the acceptor, when it comes to the knowledge of the proposer.

Thus, the provision makes no difference in the position of the offeror. The offeror becomes bound when a properly addressed and adequately stamped letter of acceptance is posted. The acceptor does not become bound by merely posting his acceptance. He becomes bound only when his acceptance comes to the knowledge of the proposer. The contract is concluded at the place from where the proposal is accepted and communication of acceptance is dispatched, *i.e.*, the address at which the proposal was sent. The court at that place would have jurisdiction to entertain a cause of action under the contract. This rule, that the communication of an acceptance is complete as against the proposer when the letter is posted, is probably intended to apply only when the parties are at a distance and they communicate by post. "Where, however, the parties are in each other's presence or, though separated in space", they are in direct communication, as, for example, by telephone, no contract will arise until the offeror receives the notification of acceptance.

It is a well settled principle of contract law that parties cannot by contract exclude the jurisdiction of all courts. The Supreme Court has observed that though the rule is technical in nature yet the general doctrine of res judicata is based on public policy and therefore, it cannot be treated as irrelevant or inadmissible even in dealing with fundamental rights in petitions filed under Article 32 of

the Constitution of India. The court observed that if a writ petition filed by a party under Article 226 of the Constitution of India is considered on merits as a contested matter and is dismissed, the decision thus pronounced would continue to bind the parties unless it is otherwise modified or reversed in appeal or other appropriate proceedings permissible under the Constitution of India. It would not be open to a party to ignore the judgment of the High Court and move Supreme Court under Article 32 by an original petition made on the same facts and for obtaining the same or similar orders or writs. Marriage is necessarily the basis of social organisation and the foundation of important legal rights and obligations. If at the time of performance of the marriage rites and ceremonies, one or other of the parties had a spouse living and the earlier marriage had not already been set aside, the later marriage is no marriage at all. The Supreme Court in Bhaurao Shankar Lokhande v. State of Maharashtra, [AIR 1965 SC 1564] held, "Prima facie, the expression 'whoever marries' in Section 494 of the Indian Penal Code, 1860 (which defines the offence of bigamy) must mean 'whoever marries validly' or 'whoever marries and whose marriage is a valid one'. If marriage is not valid according to the law applicable to the parties, no question arises of its being void by reason of its taking place during the life of the husband or wife of the person marrying. One of the conditions of a valid marriage under the Hindu Marriage Act, 1955 is that it must be 'solemnised'. Further, Section 13 (2) of the Act provides for grounds of divorce to wife and states, "A wife may also present a petition for the dissolution of her marriage by a decree of divorce on the ground that in the case of any marriage solemnized before the commencement of this Act, that the husband had married again before such commencement or that any other wife of the husband married before such commencement was alive at the time of the solemnization of the marriage of the petitioner: Provided that in either case the other wife is alive at the time of the presentation of the petition".

These two grounds specified in Section 90 are analogous to coercion and mistake of fact which are the familiar grounds that can vitiate a transaction under the jurisprudence of our country as well as other countries. The factors set out in the first part of Section 90 are from the point of view of the victim. The second part of Section 90 enacts the corresponding provision from the point of view of the accused. It envisages that the accused too has knowledge or has reason to believe that the consent was given by the victim in consequence of fear of injury or misconception of fact. Thus, the second part lays emphasis on the knowledge or reasonable belief of the person who obtains the tainted consent. The requirements of both the parts should be cumulatively satisfied. In other words, the court has to see whether the person giving the consent had given it under fear of injury or misconception of fact and the court should also be satisfied that the person doing the act *i.e.*, the alleged offender, is conscious of the fact or should have reason to think that but for the fear or misconception, the consent would not have been given. This is the scheme of Section 90 which is couched in negative terminology. Section 90 cannot, however, be construed as an exhaustive definition of consent for the purposes of the Indian Penal Code, 1860. The normal connotation and concept of 'consent' is not intended to be excluded. Various decisions of the High Court and of Supreme Court have not merely gone by the language of Section 90, but travelled a wider field, guided by the etymology of the word 'consent'.

To date, most people with mental illness remain silent about their condition, avoiding discussing their problems for fear of losing face, damaging their reputation or jeopardising their family status. Having a space where they may be welcomed and listened to, rather than judged, will go a long way towards enabling them to share their experiences. In a small part of rural Andhra Pradesh, researchers used posters, pictures, drums, and a short street play, as an intervention technique to reduce mental health stigma. An actor portrayed a person's journey through mental health crises and setbacks before receiving support and showing hope, improvement and recovery. People assembled around the stage, willing to talk about and discuss what they saw, even two to three years after the event.

Asia is at the front line of climate change. Extreme heat in India, Pakistan, and Bangladesh, wildfires in Australia, typhoons in Japan, are real and present dangers and likely to become more frequent as climate change intensifies. McKinsey's report on 'Climate risk and response in Asia', finds that, without adaptation and mitigation, Asia is expected to experience more severe socioeconomic impacts of climate change than other parts of the world. Large cities in the Indian Subcontinent could be among the first places in the world to experience heat waves that exceed the survivability threshold. Just as information systems and cyber-security have become integrated into corporate and public-sector decision making, climate change will also need to feature as a major factor in decisions. Climate science tells us that some amount of warming over the next decade is already locked in due to past emissions, and temperatures will continue to rise. India anticipates a significant infrastructure build out over the next decades with projects worth \$1.77 trillion across 34 sub sectors, according to the National Infrastructure Pipeline. COVID-19 infections are once again on the rise with daily infections crossing 60,000 per day last week. This is considerably higher compared to the reported infections during the same period last year when the numbers were less than 500 per day. What is obvious is that the pandemic is far from over despite the availability of vaccines. However, unlike last year, the response this time has been muted with no nationwide lockdown. One of the reasons for the differing responses is the lesson from the unintended consequences on the economy of the strict lockdown last year. While aggregate estimates on the growth rate of GDP showed a sharp contraction in economic activity (the economy shrunk by 24 per cent in the April-June quarter of 2020) the impact on lives and livelihoods is still unfolding even though the sharp contractionary phase seems behind us. The extent of the loss of lives and livelihoods is becoming clear only now, with detailed data from the Periodic Labour Force Surveys (PLFS) - the latest round of which is for the April-June quarter of 2020. This is the first official report on the estimates for the quarter, which witnessed the worst impact with the lockdown in force until the middle of May. Visuals of thousands of migrants walking back to their villages are still fresh in the mind. While many have returned to urban areas in the absence of jobs in rural areas, many did not. The PLFS, which captures the employment-unemployment situation in urban areas, provides some clues to what happened. The estimates from PLFS are broadly in line with estimates available from other privately conducted surveys, notably the unemployment surveys of the Centre for Monitoring Indian Economy (CMIE). According to the PLFS April-June 2020 round, the urban unemployment rate for the population above the age of 15 was 20.8 per cent, which is close to the monthly average for the same quarter from CMIE at 19.9 per cent. The CMIE data, however, does suggest a sharp decline in June compared to April and May. Similar to the CMIE data, the PLFS data also shows a sharp rise in the unemployment rate which more than doubled compared to the unemployment rate in the preceding quarter of January-March 2020 at 9.1 per cent and 8.8 per cent in the same quarter (April-June) of 2019. While one in five persons above the age of 15 was unemployed during April-June 2020, the unemployment rate among the 15-29-yearolds was 34.7 per cent - every third person in the 15-29 age group was unemployed during the same period. These are staggering numbers, but not surprising. While the lockdown certainly contributed to the worsening of the employment situation, particularly in urban areas, the fact that the economy was already going through severe distress as far as jobs are concerned is no longer surprising. Between 2016-17 and 2019-20, growth decelerated to 4 per cent, less than half the 8.3 per cent rate in 2016-17. The fact that the economy has not been creating jobs predates the economic shocks of demonetisation and the hasty roll-out of GST. The PLFS data from earlier rounds have already shown the extent of the rise in unemployment compared to the employment unemployment surveys of 2011-12. The unemployment rates in urban areas for all categories increased by almost three times between 2011-12 and 2017-18. On an internationally comparable basis, the unemployment rate among the 15-24 year olds in 2017-18 was 28.5 per cent, which makes the youth unemployment rate in India amongst the highest in the world, excluding small countries and conflict-ridden countries. Since then, it has only worsened or remained at that level.

This, even as the tests have only increased, the positivity rate has dropped and almost all Indian hospitals are seeing a drop in COVID-19 admissions and fatalities. To think that the Deep Indian State is capable of fudging data at the level of every district and every state, and sustaining this façade for months is giving it way too much credit. Conspiracies require enormous co-ordination and effort and it isn't quite how things work in India. Given that you can check corona data at every ward level, it is also impossible to fudge data, not to mention create a downwards curve that is moving in the same direction in virtually every corner of India. In terms of testing, while a case might be made for a lot of Indians not getting tested, it is also true that random testing has increased in the last few months. Domestic flyers into Maharashtra from many states for instance, have to get a COVID-19 test done irrespective of symptoms. If there was rampant corona, we would see a spike in cases from just these flyers. It may be hard for people to accept this reality but almost all evidences point to the fact that India has flattened the corona curve, while the US, UK and most of Europe still haven't. ENGLISH LANGUAGE

1. Option (b) is correct.

According to the passage, there is nowhere indicated that Holmes' was Watson's mentor, but by their conversation in the first part of the passage, it can be inferred that they used to know each other very well and were aware of each other's whereabouts. Hence, option (a) is incorrect. Option (d) states that Watson shares all his personal matters with Holmes – again it cannot be inferred from the passage, in fact, according to the passage, Watson was coming back from the harness, and before going there he didn't tell Holmes about it.

While elaborating on detectives' style of working Watson used the third person pronoun "They", which implicates that he is not one of them. Hence, Option (c) Watson is a detective is incorrect.

"I rang my own." From this sentence it can be inferred that Watson used to live with Holmes, formerly means – earlier or in past.

2. Option (a) is correct.

Refer to these lines of the passage - G.K. Chesterton's as criminals do. In option (b) only sympathetic approach is mentioned whereas in option (a) both sympathetic and empathetic approaches are mentioned, so we can conclude that option (a) is correct.

Option (c) says that Father Brown relies on a deductive analysis of the crime and his ability to sympathize. The term deductive means moving from generalizing to a specific conclusion.

According to the passage, Father Brown relied on introspection and intuition and didn't follow any kind of deductive reasoning and analysis. Refer to these lines of the passage "Father Brown introspection, intuition, and empathy".

3. Option (a) is correct.

According to the passage, all the three detectives – Holmes, Father Brown, and Hercules has different styles and skill sets to solve cases. Refer to these sections of the passag:

"Hercule Poirot happened." The essential characteristic of Hercules that assisted him in solving the case is his patience, hence, (d) is incorrect.

"Father Brown I knew who he was." According to the passage, Father Brown uses his exceptional ability to analyse a situation and person sympathetically and empathetically to solve cases.

By going, through the details of all the three detectives working styles, the only non-essential characteristic is forgiving nature.

4. Option (d) is correct.

Refer to these lines from the passage. "Hercule Poirot he uncovers the truth."

According to the passage, Poirot listened to the details given by people vigilantly, he kept accounts of the various versions of the stories told by others, and then, he collected, correlated, and identified the truth. After seeking and collecting information, he doesn't make his own version of the story, so options (a) and (c) are incorrect. Also, he does not show sensitivity towards the people while seeking information, so option (b) is incorrect.

Poirot, after patiently listening to the stories from others, identifies why and how the pieces of the jig-saw don't fit together, analyzes the missing links and then uncovers the truth.

5. Option (c) is correct.

In the passage, 'incorrigible' has been used as an adjective, which means one who is incapable of being corrected, changed, reformed, or amended. Option (d) incurable, which means that cannot be cured, is a synonym for the word incorrigible.

Option (a) habitual, is also a synonym that means doing something constantly, regularly and something that is done in a set pattern.

Option (b) unperformable means not capable of being performed or done.

Option (c) repentant means expressing or feeling sincere regret and remorse; feeling ashamed. One who admits his mistakes, feels ashamed, and is ready to correct it.

Thus, option (c) is an antonym of incorrigible.

6. Option (a) is correct.

All the above-mentioned options are known as various writing styles. They are the ways a writer chooses to express his thoughts and ideas; through a piece of writing. Generally, RC passages present information in the following six writing forms: Narrative

Descriptive

Factual/Expository/Informative

Argumentative/Persuasive

Analytical

Abstract

Narrative paragraphs talk about an event or series of events, usually in chronological order. The author, through narrative style, intends to narrate some events or personal experiences.

Descriptive writing aims to help the reader visualize, in detail, a character, event, place, or all of these things at once. The author might describe the scene in terms of all five senses.

The word expository contains the word expose, *i.e.*, to reveal, in this we expose facts. This writing style is implied when the writer does an in-depth research of a topic and presents it as an investigation report showing the various angles, aspects, and analysis.

The abstract style of writing is adopted in passages that deal with abstract topics such as related to philosophy. It generally encompasses non-material concepts that may be represented symbolically.

The given passage shows an account of comparing two different ways of handling a project. One set gives more importance to the planning process before execution while the other gives weightage to execution. The author here has supported and presented both the aspects with facts and quotations by renowned leaders. Hence, we can conclude that the writing style used by the author in this passage is Expository and thus, option (a) is correct.

7. Option (b) is correct.

Refer to these sentences from the passage, "A balance easy journey."

This is the concluding statement of the passage, "Think plans capricious weather."

The author's main idea behind the passage is to convey that execution, planning, and strategy, three are equally important. Option (b) does justification to the central idea conveyed by the author, rest of the three options are partially connected to the passage but are not the central purpose of the author.

8. Option (d) is correct.

9. Option (b) is correct.

Refer to these quotes given by Steve Jobs and Benjamin Franklin respectively -

"To me, ideas are worth nothing unless executed. They are just a multiplier. Execution is worth millions."

"Failing to plan is planning to fail."

By going through these quotes it can be easily concluded that Steve Jobs gave weightage to execution as compared to ideas whereas Benjamin considered planning to be more important. Hence, we can say that Benjamin Franklin's and Steve Job's approaches were entirely different from each other.

10. Option (c) is correct.

In the phrase 'Consumer is the capricious weather,' the consumer has been compared to capricious weather, which means that consumers can be unpredictable and impulsive just like the weather. The words wavering and unpredictable are synonyms of the word capricious. Hence, as per the second blank, both (b) and (c) are suitable. Options (a) and (d) are incorrect.

A metaphor is a figure of speech that makes an implicit, implied, or hidden comparison between two unrelated things, but which share some common characteristics. In the sentence, consumer and weather don't share any common ground but are still being compared without the use of 'like', 'as' or 'so'. Hence, it is a metaphor. Thus, option (c) is the most appropriate combination.

11. Option (b) is correct.

The prime motive behind the passage is to throw light on the current vaccination scenario and how India's approach is different from it. In the passage, it is discussed, at one hand there are countries like Canada, UK, USA in which second and third vaccination drive is on, still they have turned their back on the need of poor countries and on the other end a developing nation like India in which the first round of vaccination has hardly started, has taken initiative to help poor countries which are incompetent to produce vaccines.

Refer these lines from the passage, "While India COVID-19 under control."

Hence, as per option (b) the purpose of this passage is to encourage global cooperation and discourage vaccine nationalism.

12. Option (d) is correct.

According to the passage 'inoculation process' means vaccination drive. A vaccine is a biological composition which is used to stimulate the production of antibodies, in-turn providing immunity against one or few diseases. Hence, inoculation process is an entire procedure to induce immunity in people by artificially inducing vaccine.

13. Option (a) is correct.

Option (c) and (d) are talking about the entire **global** well-being and world population whereas **the** passage is discussing just about developed countries.

Option (b) is talking about bringing back the power to the nations which is again beyond the scope of the passage as vaccine is linked to health and wellbeing of the people.

14. Option (d) is correct.

Export of vaccines by India can have negative repercussions among people from India as India is still in its initial stages of vaccination drive and export can lead to a dearth of vaccines within the country.

15. Option (d) is correct.

According to the passage, to ensure healthy lives for all at all ages, the inoculation process has to be implemented properly and globally. It has to be implemented across the globe, be it an underdeveloped nation, a developing nation or a developed nation.

If advanced countries would vaccinate their population multiple times; leaving those people aside, who are from underdeveloped countries and, who have not been vaccinated even once then it would hinder the SDGs goal of global well-being. Hence, options (b) and (c) are the reversals of SDGs goal.

Option (a) states that arguments for public good and global co-operation have gone out of the window now, which again depicts the reversal of SDG goals.

16. Option (b) is correct.

'Rather than pursuing the status quo.' According to the passage, status quo means already prevailing structure and conditions which the TRC the commissioners did not want to go against.

17. Option (d) is correct.

The tone of a passage is primarily the author's sentiment or attitude towards the subject being discussed. It's the predominant emotion that the author displays towards the subject.

We can say that the author is using a critical tone when he criticizes, finds faults, and shows dejection. He does a deep analysis of an issue with an impartial outlook and sometimes use a harsh tone as well. The prime concern of the author in the given passage is to elaborate on the commencement and functioning of TRC. The selection of words and the sentence structure used by the author clearly implies that he is critical of the TRC's commissioners and their approach and their way of working. Hence, option (d) is correct.

Optimistic means hopeful and positive. When writing in an optimistic tone, the author conveys a sense of hope, and a positive outlook for the future.

When the author shows concern and presents sympathy towards somebody, the tone used is said to be compassionate whereas threatening tone of a passage is when the author uses words to show a sign of danger to readers, projects a warning or an alarming situation.

18. Option (b) is correct.

According to the passage, "The Truth concept of truth." TRC came up as an organized commission to cope with the past regime through the concept of truth, which makes option (a) incorrect.

Refer these lines from the passage, "Emerging as a political strategy objectives." From this sentence it can be easily derived that, option (c) and (d) are the concerns of TRC.

Hence, option (b) that says that TRC's broader concern was first to acknowledge past sufferings is incorrect.

19. Option (c) is correct.

As per the passage, "The public transition the status quo."

TRC maintained an agenda that avoided a challenge to already prevailing conditions, hence option (d) can be inferred from the passage.

From the same part of the passage, we can infer that TRC lacked sincere efforts to accomplish the objectives because of which it was commenced. Hence, option (c), is the least likely statement that can be inferred from the passage.

According to these lines derived from the passage," Rather than pursuing truth to the status quo."

Hence, it can be inferred that TRC was not successful in its agenda of social transformation.

"These sub-committees, social transformation'."

TRC considered few broad areas leaving aside few other areas which were of concern.

20. Option (d) is correct.

Amnesty refers to official pardon given to those who have violated human rights. "More difficult come forward."

Amnesty is defined as 'A pardon extended by the government to a group or class of people, usually for a political offense; the act of a sovereign power officially forgiving certain classes of people who are subject to trial but have not yet been convicted.' Options (a), (b) and (c) are all antonyms to the word amnesty.

21. Option (a) is correct.

Noam Chomsky says, "You cannot pursue any kind of inquiry without a relatively clear framework that is directing your search and helping you choose what is significant and what is not." By this quote, it can be inferred that Noam is stating that technology can only help in the best way when it is used in a precise way, with a clear purpose and with a structured framework. Option (b) is talking about just the clear framework of any kind of inquiry, but a very important point is missing in the option *i.e.*, direction and purpose of the inquiry. Option (c) says that technology helps to choose which is again correct but partially. It is not summarizing the complete quote.

Option (d) is correct as per the passage but is not linked to Noam Chomsky's quote.

Option (a) states that technology shall be used in purposively structured manner in education. It is summing up Noam's quote completely and is mentioning both the important points - purpose and clear framework.

22. Option (d) is correct.

A premise is a statement in an argument that provides evidence or reasons to form a conclusion. It contains the information that leads us to believe that an argument is true. As per the given options, options (a), (b) and (c) support and strengthen author's argument in favor of schools and colleges. All the three arguments are setting up a base for the argument by adding that schools and colleges provide opportunities for socialization and the current pandemic has proven that students and parents want schools and colleges. On the other hand, option (d) is not related to schools and colleges rather it's discussing the appropriate usage of internet surfing.

23. Option (c) is correct.

The word 'heterogeneity' means the quality or state of being diverse in character or content. Things which are poles apart and are extremely different from each other. Option (a) is discussing about unity and option (d) is discussing about identity, both of which are antonyms to the word heterogeneity.

Option (b) talks about unity in diversity, which is an expression, that is used to identify unity and harmony between dissimilar groups.

Option (c) discusses diversity, which is a synonym to the word heterogeneity, and is the correct option.

24. Option (b) is correct.

Whereas, option (b) is partially correct, according to the passage, "it has shown that technology thoughtfully." As per the author, from the pandemic, it was made clear that technology is useful only when it is used with a purpose and within a structured framework.

25. Option (c) is correct.

The word symbiosis means, a cooperative and interdependent relationship between individuals in which both are benefitted equally. Hence, option (c) is correct.

The word exclusive means something that is restricted to a particular person and if it is restricted to a single individual there is definitely no mutual benefit. Hence, option (b) is incorrect.

The word inclusive used in option (a) means including and comprising of everybody, which again doesn't represent mutual benefit. Hence, this option is also incorrect.

26. Option (a) is correct.

Refer to these lines from the passage, 'The report by Boston Consulting Group and Michael & Susan Dell Foundation 1.25% to India's GDP.'

According to the Boston Consulting Group and Michael & Susan Dell Foundation gig jobs will increase from 8 million to 90 million in a decade, hence, option (a) is correct. As per option (b) they predict a shift in nature of work which is incorrect as they don't mention any shift in the work pattern. Option (c) states that they predict rise in World's GDP whereas as per their report they predicted 1.25% rise in India's GDP.

27. Option (b) is correct.

Refer these from the passage, "There is room health infrastructure." whereas option (c) represents an opposite relation between infrastructure support and gig economy.

As per the passage, "Expecting startups investment." Hence option (b) can be inferred from the above lines, that treating gig workers as regular employees may hinder innovation and investment.

In the passage, the author is talking about socio economic framework whereas in Option (d) they are linking socio- political framework to gig jobs. Refer the sentence "it is equally critical to create the socio-economic framework that can support such jobs."

Option (a) cannot be inferred as caution as the investment of government on public health, education, insurance and food security will help in overcoming the anxieties of gig workers.

28. Option (a) is correct.

After thoroughly going through the passage, we can find several descriptions and words inked to the term – gig viz- temporary jobs, informalization etc. According to the passage, gig economy is related to an informal structured economy with temporary or short term, freelance labour and workers participating actively in it. Hence, option (a) is correct. Option (b) talks about shift in nature of work which is not the complete description of the gig economy. Option (c) discusses about source and type of funds involved in economy.

29. Option (d) is correct.

The tone of a passage is primarily the author's sentiment or attitude towards the subject being

discussed. It's the predominant emotion the author displays towards the subject.

We can say that an author uses a cynical tone when he is doubtful and skeptical about any issue. He uses negative words and is pessimistic about whether something will happen or not.

When an author is critical, he criticizes, finds faults and shows dejection. He does deep analysis of an issue with an impartial outlook and sometimes uses harsh tone as well.

A scornful tone exhibits the author's disdain or contempt towards the subject. In such passages, the author treats the subject in a disrespectful and ridiculous way.

30. Option (c) is correct.

According to the passage, the author comes out to be concerned about the quality of life and social security of the people engaged in these gigs, "Although the jury much earlier."

As per the passage, "The gig economy health infrastructure."

Educational and health infrastructure help to improvise the technological area, which leaves an impact on the job market. Hence, option (a) is incorrect.

According to the passage, one of the characteristics of the gig economy is its temporary and flexible nature, option (b) is not a concern as per the passage.

CURRENT AFFAIRS INCLUDING GENERAL KNOWLEDGE

31. Option (c) is correct.

India and China on June 15-16, 2020, engaged in their first deadly face-off since 1967. 20 Indian soldiers including the Commanding Officer of 16th Bihar Regiment, Col Babu lost their lives in the hands of Chinese army in the **Galwan Valley**.

32. Option (c) is correct.

The Indian and Chinese armies were engaged in the standoff in Pangong Tso, Galwan Valley, Demchok and Daulat Beg Oldie in eastern Ladakh.

• The Galwan Valley area comes under Sub Sector North which lies just to the east of the Siachen glacier and is the only point that provides direct access to Aksai Chin from India.

33. Option (b) is correct.

In June, 2020 when the initial process of disengagement was going on, the violent clash occurred on June 15-16, at Patrol Point (PP) 14 in Galwan Valley.

 Patrol Points 10 to 13 in Depsang sector, Patrol Point 14 in Galwan, Patrolling Point 15 in Hot Spring, and Patrol Point 17 and Patrol Point 17A in Gogra are currently being disputed by both sides, where the standoffs have taken place in the past nine weeks. • These Patrolling Points have been identified by the high-powered China Study Group, starting from 1975 when patrolling limits for Indian forces were specified.

34. Option (d) is correct.

The LAC is the demarcation between India and China. It separates Indian-controlled territory from Chinese-controlled territory. India considers the LAC to be 3,488 km long which is the second biggest international border of India, while China considers it to be around 2,000 km.

• LAC is divided into three sectors, the eastern sector which spans Arunachal Pradesh and Sikkim (1346 km), the middle sector in Uttarakhand and Himachal Pradesh (545 km), and the western sector in Ladakh (1597 km).

35. Option (d) is correct.

India and China signed an agreement on 11 Feb, 2021 according to which

- Chinese side to move back its troops on the north bank to east of finger 8.
- Indian troops to move to their permanent base at Dhan Singh Thapa post near finger 3.
- A similar action would be taken in the south bank area by both sides.
- The structures built by both sides since April 2020 in both north and south bank area to be removed to restore the land forms.
- Moratorium on patrolling in this affected area until resumption is discussed by both sides.

36. Option (a) is correct.

The current minister is Mansukh L. Mandaviya, from Gujarat who succeeded Dr. Harsh Vardhan in July, 2021, after the recent reshuffle of Union Cabinet by the President of India.

37. Option (b) is correct.

On 15 March, 2020 during SAARC leaders conference on combating COVID-19, India proposed creation of a COVID-19 Emergency Fund of \$20 million. The fund is based on voluntary contribution from all SAARC members to combat COVID-19 in the region.

Further, **\$10 million** has been extended by India, Sri Lanka (\$5 million), Bangladesh (\$1.5 million), Nepal (\$1 million), Afghanistan (\$1 million), Maldives (\$200,000) and Bhutan (\$100,000) taking the total amount in the Covid-19 Emergency Fund to \$18.3 million.

38. Option (d) is correct.

India sent COVID-19 vaccines under grant assistance to Bhutan, Maldives, Bangladesh, Nepal, Myanmar and Seychelles. Among these, Bhutan and Maldives were the first to receive COVID-19 vaccines from India.

39. Option (c) is correct.

During the first wave of the pandemic, focus of Indian Govt. was on coordinating exports of COVID-19 medicines, flights to repatriate Indians abroad through the 'Vande Bharat Mission' after the lockdown, and then exporting vaccines worldwide under the initiative called 'Vaccine Maitri'.

40. Option (a) is correct.

COVAXIN is developed by Bharat Biotech International Limited (BBIL) in collaboration with Indian Council of Medical Research (ICMR) and National Institute of Virology, Pune an institute of ICMR.

41. Option (c) is correct.

The International Human Rights Day is observed every year on 10th of December. On this day in 1948, the Universal Declaration of Human Rights (UDHR) was adopted by the United Nations General Assembly (UNGA).

The International Human Rights Day-2020 Theme: Recover Better - Stand Up for Human Rights.

42. Option (a) is correct.

The Human Rights Council is an intergovernmental body within the United Nations system responsible for strengthening the promotion and protection of human rights around the world. It was setup by the United Nations General Assembly on 15 March, 2006.

43. Option (b) is correct.

Universal Declaration of Human Rights (UDHR) is not a treaty, so it does not directly create legal obligations for countries. Several member countries have their own a separate human rights organisation.

The UDHR, together with the International Covenant on Civil and Political Rights and its two Optional Protocols (on the complaints procedure and on the death penalty) and the International Covenant on Economic, Social and Cultural Rights and its Optional Protocol, form the so-called International Bill of Human Rights.

44. Option (d) is correct.

To promote religious dogmatism is not an object of 'Faith for Rights' (F4R).

There are 18 main objectives of F4R.

- Refraining from using messages of intolerance that may incite violence, hostility or discrimination;
- Speaking out firmly and promptly against intolerance, discriminatory stereotyping and instances of hate speech;
- Stand up for the rights of all persons belonging to minorities;

- Publicly denounce all instances of advocacy of hatred that incites to violence, discrimination or hostility;
- Monitor interpretations, determinations or other religious views that manifestly conflict with universal human rights norms and standard to refine the curriculum, teaching materials and textbooks;
- Revisit religious interpretations that appear to perpetuate gender inequality and harmful stereotypes or even condone gender-based violence.

45. Option (b) is correct.

The National Human Rights Commission (NHRC) established in 1993, is an independent statutory body as per the provisions of the Protection of Human Rights Act of 1993 which was amended in 2006.

Human Rights are an indispensable part of a civilized society. NHRC acts as a watchdog of human rights in India.

46. Option (c) is correct.

In 1993, United Nations General Assembly decided to celebrate 22 March of every year as World Water Day. This day is celebrated to increase the awareness among the people about the need and conservation of water.

47. Option (a) is correct.

The theme of the World Water Day-2021 is **"Valuing Water"** to focus on "How we can better protect this vital resource".

48. Option (b) is correct.

Prime Minister Shri Narendra Modi launched the 'Jal Shakti Abhiyan (JSA): Catch the Rain' campaign on World Water Day. JSA is a time bound mission mode water conservation campaign. It aims at making water conservation a Jan Andolan through asset creation and extensive communication.

49. Option (c) is correct.

Goals of National Water Mission (NWM)

- Comprehensive water data base in public domain and assessment to impact of climate change on water resources.
- Promotion of citizen and state action for water conservation, augmentation and preservation.
- Focused attention to vulnerable areas including over exploited areas.
- Increasing water use efficiency by 20%.
- Promotion of basic level integrated water resources management.

50. Option (a) is correct.

The Ministry of Jal Shakti was formed by merging the Ministry of Water Resources, River

Development and Ganga Rejuvenation and Ministry of Drinking Water and Sanitation in May 2019.

51. Option (d) is correct.

The Gandhi Peace Prize was instituted by the Government of India in 1995 during the commemoration of the 125th birth anniversary of Mahatma Gandhi.

- The award is given to those involved in social, economic and political transformation through non-violence.
- The award carries an amount of ₹1 crore, a Citation in a scroll, a plaque as well as an exquisite traditional handicraft/handloom item.
- The annual award is given to individuals associations, institutions or organisation who have worked selflessly for peace, non-violence and amelioration of human sufferings.

52. Option (a) is correct.

The first ever Gandhi Peace Prize was given to Julius Nyerere, the Tanzanian politician who served as the leader of Tanzania and promoted African nationalism and socialism.

He preached Gandhian teachings as he was greatly influenced by Mahatma Gandhi.

Option (c) is correct.

53.

The Gandhi Peace Prize, instituted as a tribute to the ideals backed by Gandhi, was conferred in 2014 to the Indian Space Research Organisation (ISRO). ISRO was established in August 1969.

54. Option (b) is correct.

Sheikh Mujibur Rahman, popularly known as Bangabandhu, is considered to be the force behind the independence of Bangladesh. He became the first President of Bangladesh and later, the Prime Minister until his assassination on 15 August, 1975. He was given Gandhi Peace Prize-2020 for his outstanding contributions towards social, economic and political transformation through non-violent and other Gandhian methods.

55. Option (c) is correct.

On 15 August 1975, a group of junior army officers invaded the presidential residence with tanks and killed Mujib, his family and personal staff. Only his daughters Sheikh Hasina and Sheikh Rehana, who were visiting West Germany at the time, escaped.

56. Option (d) is correct.

India commemorated 'Chabahar Day' on 4 March on the sidelines of the Second edition of International Maritime Summit-2021 held from March 02-04, 2021.

57. Option (c) is correct.

Chabahar Port is located in the Gulf of Oman on the south eastern coast of Iran. It is only 72 km away from the Gwadar port in Pakistan which has been developed by China. It has marine border more than 300 km.

The port is a key pillar of Indo-Pacific vision of India to connect Eurasia with the Indian Ocean Region.

58. Option (d) is correct.

Chabahar port is a major transit point to connect with several Central Asian countries.

- It is the only Iranian port which has direct access to the Indian Ocean.
- Due to its closeness to Afghanistan and the Central Asian countries of Turkmenistan, Uzbekistan etc., it gives a boost to India's bilateral ties with Iran which is a major oil supplier for India.
- It will give India access to Afghanistan, Russia and Europe, thus circumventing Pakistan.
- The port and the rail project (Chabahar to Zahedan to Zarang near Afghanistan border) will enhance connectivity, energy supplies and trade.
- The port is a key link in the International North South Transport Corridor (INSTC), a multimodal network of ships, rail and road routes to move freight between India to Russia via Iran.
- Being the nearest port to India on the Iranian coast, it provides access to the resources and markets of Afghanistan and Central Asia.

59. Option (a) is correct.

The Chabahar port is a result of trilateral agreement between Iran, Afghanistan, and India. The three countries agreed on the routes for trade and tourist corridors between them.

60. Option (c) is correct.

India Ports Global Ltd. (IPGL), Mumbai is incorporated under the shipping ministry as a Special Purpose Vehicle jointly promoted by

66. Option (b) is correct.

Volenti non fit injuria will be applicable and no compensation can be claimed. It is a common law doctrine, according which a person who voluntarily gives consent for any harm to suffer would not be liable to claim any damages for the same and this consent serves as a good defence against the plaintiff.

Mr. B and Mr. C took lift from Mr. D in his car who was a stranger and Mr. D had not offered them his services first so, here the doctrine of Volenti non fit injuria will be applicable and so, Mr. A and Mr. D will not be liable for any compensation.

67. Option (a) is correct.

Rama impliedly took the risk of such injury, the danger being inherent in the sport which any

Jawaharlal Nehru Port Trust (JNPT) and Deen Dayal Port Trust (DPT) for the development and management of Shahid Beheshti Port of Chabahar.

61. Option (b) is correct.

Dal Lake, Jammu and Kashmir is not included in the Ramsar Wetland List. There are 54 wetlands in India that have international importance and are hence recognized as the Ramsar Sites in India. There are currently over 2400 Ramsar sites in the world covering an area of 2.5 million sq. kilometres.

62. **Option** (c) is correct.

World Wetlands Day is celebrated on February 2. The Ramsar Convention was signed on February 2, 1971 and came into force in 1975. The convention came into force on Feb. 01, 1982 in India.

63. Option (b) is correct.

The year 2021 commemorates the 50th anniversary of the Convention on Wetlands signed on 2nd February 1971 in the Iranian city of Ramsar. The theme for 2021 is 'Wetlands and Water'.

64. Option (a) is correct.

The Sundarbans Reserve forest is located across India and Bangladesh on the delta of the Ganges, Brahmaputra and Meghna rivers the Bay of Bengal. It is the largest contiguous mangrove forest in the world.

65. Option (d) is correct.

To fulfill its commitment towards conservation, restoration and management of India's wetlands, the Govt. announced the establishment of a Centre for Wetland Conservation and Management (CWCM), as a part of the National Centre for Sustainable Coastal Management (NCSCM), on the occasion of the World Wetland Day celebrated on February 02, 2021.

spectator could foresee, the defendant was not liable as per the doctrine of Volenti non fit injuria. Rama knew the nature of the sport and had full knowledge about it and agreed to suffer the risk involved in the act and thus, Rama can not make a claim for the injury.

68. Option (a) is correct.

Knowledge of the risk does not always amount to consent. When the plaintiff has the knowledge that the act is going to cause harm or loss and in spite of that accepts to do it, agreeing to suffer the injury, then the defendant will not be liable for such an act as per the set doctrine Volenti non fit injuria.

In the case of Dan vs. Hamilton, the plaintiff chose to travel in defendant's car, even though he knew that the defendant was drunk. The car crashed causing injuries to him. The defence of volenti non-fit Injuria is applied when there is "complete knowledge of the danger" and proof of the person consenting to it.

69. Option (d) is correct.

Karan had knowledge of the spring guns and willfully courted the danger himself. In this question, the plaintiff was aware that Lily had placed spring guns to protect her garden, so he cannot claim for his injury whereas if Karan had not been aware of this situation then Lily would have been liable for the injury of Karan.

70. Option (c) is correct.

Plaintiff is compelled to agree to a risk by the defendant because in case the consent of a person is not free, the defendant cannot claim this defence to escape liability and he will be held liable for damage caused. In cases of consent having been obtained by fraud, the defence of volenti non fit injuria will not apply and the defendant will be held liable for the wrong done by him.

71. Option (a) is correct.

A misrepresentation is a positive statement of fact, which is made or adopted by a party to a contract and is untrue. Essentials of misrepresentation:

- 1. The misrepresentation must be of material facts
- **2.** The misrepresentation must be false, but the person making it honestly believes it to be true
- 3. The misrepresentations must induce the other party to enter into contract
- 4. The misrepresentation must have been addressed by one party to the party misled
- 5. Change of circumstances, may amount to misrepresentation

72. Option (c) is correct.

'Fraud' means and includes any of the following acts committed by a party to a contract, or with his connivance, or by his agent:

- the suggestion, as a fact, of that which is not true, by one who does not believe it to be true;
- (2) the active concealment of a fact by one having knowledge or belief of the fact;
- (3) a promise made without any intention of performing it;
- (4) any other act fitted to deceive;
- (5) any such act or omission as the law specially declares to be fraudulent.

So, all three statements correctly describe a fraudulent act.

73. Option (b) is correct.

The major differences between fraud and misrepresentation are as under:

1. Fraud is a deliberate misstatement of a material fact. Misrepresentation is a bonafide

representation of misstatement believing it to be true which turns out to be untrue.

- 2. Fraud is done to deceive the other party, but Misrepresentation is not done to deceive the other party.
- 3. In fraud, the party making representation knows the truth however in misrepresentation, the party making representation does not know the truth.
- 4. In fraud, the aggrieved party can claim damages for any loss sustained. On the other hand, in misrepresentation, the aggrieved party cannot claim damages for any loss sustained.

So, option (b) will be correct as the difference between fraud and misrepresentation is that in the former, the person making the suggestion does not believe it to be true and, in the latter, he believes it to be true.

74. Option (d) is correct.

Mere silence as to facts that are likely to affect the willingness of a person to enter into a contract is not fraud, unless the circumstances of the case are such that, regard being had to them, it is the duty of the person keeping silence to speak, or unless his silence is, in itself, equivalent to speech hence it amounts to fraud.

The correct option will be (d) as Mr. A had the knowledge that the car was defective and yet when Mr. Y says to Mr. A, "If you do not deny it, I shall assume that the car is perfect" Mr. A chose to remain silent. Mr. A has duty to speak about the car's condition but he was silent which amounts to fraud.

75. Option (d) is correct.

If such consent was caused by misrepresentation or by silence, fraudulent within the meaning of section 17, the contract, nevertheless, is not voidable, if the party whose consent was so caused had the means of discovering the truth with ordinary diligence.

A, intending to deceive B, falsely represents that five hundred mounds of indigo are made annually at A's factory, and thereby induces B to buy the factory. The contract is voidable at the option of B.

76. Option (b) is correct.

In this question the communication of acceptance is complete as against 'S' however not complete as against the company. As mentioned that the acceptance of the offer to purchase shares, was posted by the company on March 10, 2021, but the letter never reached 'S' and was lost in transit, so the acceptance as against the company is not completed.

77. Option (d) is correct.

The contract concluded in Mumbai as the offer was made by A from this place. In such case of

acceptance by phone, the contract is deemed to be complete in Mumbai when the offeror hears the acceptance at his end rather than when the acceptor speaks the words of acceptance.

Thus, option (d) will be correct, and hence, the contract was concluded in Mumbai

78. Option (a) is correct.

Option (a) will be correct as against 'X', on January 15, 2021 at 4:04 pm when unconditionally accepted by 'Y' via an e-mail sent, and as against 'Y', acceptance is read by 'X' on January 15, 2021 at 7:05 pm, when both A and X give their concent.

79. Option (c) is correct.

The offer was made by 'X', who is in Agra. Agra was the place where the offer was made and also the origin of the contract, thus, the contract ended in Agra.

80. Option (b) is correct.

The communication being instantaneous, the communication of acceptance is immediately complete as against the proposer as well as the acceptor.

- Under the provisions of the Information Technology Act, 2000 particularly Section 10-A, an electronic contract is valid and enforceable.
- The only essential requirement to validate an electronic contract is compliance with the necessary pre-requisites provided under the Indian Contract Act, 1872.

81. Option (a) is correct.

Option (a) will be correct because this clause relating to jurisdiction is in restraint of legal proceedings of either party, which stipulates that in the event of a dispute only Kolkata would have exclusive jurisdiction to decide on the dispute. The said clause was included in order to avoid dispute over choice between the two proper places of jurisdiction, Mumbai and Delhi.

In the prominent Halsbury's Laws of England, it is stated that "an agreement purporting to oust the jurisdiction of the courts is illegal and void on grounds of public policy". These types of agreements cannot be enforced.

82. Option (d) is correct.

Option (d) will be correct as the clause relating to jurisdiction is valid as courts in Chennai have jurisdiction to decide the dispute.

83. Option (a) is correct.

Any agreement is void if it is restraining any person from enforcing his/her contractual obligations through ordinary court proceedings or if it limits the time within which he/she may enforce his/her rights. The agreement is void if it extinguishes the right of any party to it, or releases any party thereof from liability, in respect to any contract on the expiry of a specified period so as to restrict any party from enforcing its rights, is void to that extent.

84. Option (d) is correct.

Both the Clause 6 and Clause 7 is void as both the options restrict a person from enforcing his/ her contractual rights through ordinary court proceedings by putting condition on the time limit, so option (d) will be correct.

85. Option (b) is correct.

The choice of jurisdiction clause specifies the country, as agreed upon by the parties, whose courts shall hear disputes arising out of the contract. Hence, option (b) will be correct.

The common law/general rule is that exercise of jurisdiction depends on service of originating court process, as service can only be effected on those actually present in the jurisdiction, or those who had submitted voluntarily or by contract to the jurisdiction.

86. Option (d) is correct.

Hon'ble Supreme Court of India has reiterated that the principle of res judicata as provided by section 11 of the Code of Civil Procedure, 1908 is applicable to writ petitions as well as civil cases.

The observation was given by the Court in view of P. Bandopadhya Vs. Union of India, a judgment of Bombay High Court which was challenged before the Apex Court.

87. Option (c) is correct.

Doctrine of Res Judicata is applicable to writs if the decision is on merits, and order is a speaking order. As per section 11 of CPC "No Court shall try any suit or issue in which the matter directly and substantially in issue in a former suit between the same parties, or between parties under whom they or any of them claim, litigating under the same title, in a Court competent to try such subsequent suit or the suit in which such issue has been subsequently raised, and has been heard and finally decided by such Court".

88. Option (d) is correct.

The doctrine of Res Judicata is originated from 3 Roman maxims:

- 1. Nemo debet bis pro eadem causa It means that no person should be vexed (annoyed), harassed two times for the same cause;
- 2. Interest republicae ut sit finis litium It means that it is in the interest of the state that there should be an end of litigation; and
- 3. Re judicata pro veritate occipitur It means that the decision of the court should be accepted as correct.

89. Option (d) is correct.

Once the question which has been decided by the Writ Petition as per Articles 32 & 226 of the Indian Constitution cannot be reopened by subsequent appeal. It is settled law that the doctrine of Res Judicata is applied in the Writ proceedings but there is one exception to this is that the plea of Res Judicata should not violate any fundamental rights of the citizens. The court can apply the principle of Res Judicata in the writ petition but it is necessary for the court to pass a speaking order. The court should give proper reasoning while applying the Res Judicata.

90. Option (b) is correct.

In this question Mr. X who was dismissed from service against which he filed a writ petition which was dismissed by the High Court citing that Mr. X has an alternative remedy available, hence, High Court itself allowed Mr. X alternative remedy and Mr. X can go to the Supreme Court. Here, Doctrine of Res Judicata will not be applied.

91. Option (d) is correct.

Option (d) will be correct regarding the intent behind the application of compassionate appointment. The norms prevailing on the date of consideration of the application should be the basis for consideration of claim for compassionate appointment.

92. Option (a) is correct.

The dependants of a deceased government employee are made eligible by virtue of the policy on compassionate appointment and they must fulfill the norms laid down by the State's policy, hence, option (a) will be correct.

93. Option (b) is correct.

In this question Mr. Y, son of Mr. X, will be entitled for the job as his father died during his employment in the company in 2000.

It was further asseverated in the said judgment that compassionate employment cannot be granted after a lapse of reasonable period as the consideration of such employment is not a vested right which can be exercised at any time in the future.

94. Option (d) is correct.

It was held that the dependants of a deceased government employee are made eligible by virtue of the policy on compassionate appointment and they must fulfill the norms laid down by the State's policy.

In the question the Government of 'N' formulated a scheme for providing compassionate appointment to the dependants of government servants who retired on medical invalidation. By a further notification, the benefit of the scheme was restricted to cases where the government servants retired on medical invalidation, at least five years before attaining the age of superannuation. The scheme is valid as it is not arbitrary and the government has the right to formulate such rules.

95. Option (c) is correct.

Applicant for compassionate appointment should be eligible and suitable for the post in all respects under the provisions of the relevant Recruitment Rules. The immediacy of the need is not the basis for the state to allow the benefit of compassionate appointment.

96. Option (c) is correct.

Section 494 of the IPC provides about "Bigamy" as thus "Whoever, having a husband or wife living, marries again in any case in which such marriage is void by reason of its taking place during the life of such husband or wife shall be punished with imprisonment of either description for a term which may extend to seven years, and shall also be liable to fine".

Hence, in the given question, Mr. A is not liable for the offence of bigamy as he has not solemnised his marriage with Ms. C, as per the Hindu marriage Act 1955 or as per Special Marriage Act 1956.

97. Option (a) is correct.

Solemnisation means celebrating the marriage with proper customary rites and ceremonies of either party to a marriage as per the Hindu marriage Act 1955 or as per Special Marriage Act 1956.

Under the Hindu Marriage Act, 1955, there are certain conditions that need to be fulfilled to consider the marriage between the parties as legal and valid. These conditions have been enshrined under Section 5 and Section 7 of the Act. The marriage is considered to be valid only if both the parties to a marriage are Hindus as per section 5 of the Act.

98. Option (b) is correct.

Monogamy is a marriage with only one partner at a time, rather than many partners. Monogamy as a law was abolished after 1955. After enforcement of Hindu Marriage Act 1955 as provided in sections 5 and 7.

With the commencement of the Hindu Marriage Act, 1955 (HMA), one of the conditions provided for a valid marriage was that neither party should have a spouse living at the time of the marriage. Under the old law, there was a bar against a woman marrying a second husband while her first husband is alive unless custom permitted her.

99. Option (b) is correct.

Section 13 in The Hindu Marriage Act, 1955, any marriage solemnised, whether before or after the commencement of this Act, may, on a petition presented by either the husband or the wife, be dissolved by a decree of divorce on the ground that the other party.

A wife may also present a petition for the dissolution of her marriage by a decree of divorce on the ground.

100. Option (d) is correct.

Mr. P, who is 28-year old male Hindu was legally married to Ms. Q, a 26-year old female Hindu, their marriage will be treated as valid and when Mr. P converts to Islam to marry Ms. N, a 30-year old Sunni female Muslim it will amount to bigamy. Hence, Ms. Q can file a complaint for the offence of bigamy.

The doctrine of indissolubility of marriage, under the traditional Hindu law, did not recognise that conversion would have the effect of dissolving a Hindu marriage. Conversion to another religion by one or both the Hindu spouses did not dissolve the marriage.

101. Option (a) is correct.

In this case consent has been taken under the under misconception of fact and A will be liable for the offence of rape. Hence, option (a) will be correct.

102. Option (c) is correct.

Consent given firstly under fear of injury and **secondly** under a misconception of fact **is** not **'consent'** at all. That is what is enjoined by the first part of Section 90. These two grounds specified in Section 90 are analogous to coercion and mistake of fact which are the familiar grounds that can vitiate a transaction under the jurisprudence of our country as well as other countries.

103. Option (d) is correct.

The factors set out in the first part of Section 90 are from the point of view of the victim. The second part of Section 90 enacts the corresponding

provision from the point of view of the accused. It envisages that the accused too has knowledge or has reason to believe that the consent was given by the victim in consequence of fear of injury or misconception of fact. Thus, the second part lays emphasis on the knowledge or reasonable belief of the person who obtains the tainted consent.

The requirements of both the parts should be cumulatively satisfied. In other words, the court has to see whether the person giving the consent had given it under fear of injury or misconception of fact and the court should also be satisfied that the person doing the act i.e. the alleged offender, is conscious of the fact or should have reason to think that but for the fear or misconception, the consent would not have been given. This is the scheme of Section 90 which is couched in negative terminology."

104. Option (b) is correct.

Consent for sexual intercourse was given without any misconception of fact or fear of injury as 'X' promised 'Y', that he will marry her if she has sexual intercourse with him. 'Y' agrees and they have sexual intercourse, then, here no misconception of facts is present, hence, option (b) will be correct.

105. Option (c) is correct.

Misconception of fact obviates the necessity of consent. The failure to keep the promise at a future uncertain date due to reasons not very clear on the evidence does not always amount to a misconception of fact at the inception of the act itself. In order to come within the meaning of misconception of fact, the fact must have an immediate relevance, hence option (b) will be correct.

LOGICAL REASONING

106. Option (c) is correct.

In the passage, the author is trying to convey the concept of mental health stigma and how it can be tackled. The author has focused on lowincome countries and has emphasized on the fact, that people in low-income countries facing mental illness remain silent, avoid discussing their problems, have fear of losing face and damaging their reputation. They don't get an appropriate environment and place where they can share their experiences and can try to come out.

As per the passage, options (a), (b), and (d) are all incorrect statements, as they are not aligned to the idea conveyed by the author in the passage.

107. Option (b) is correct.

According to the author, mental health can be improved if people get an appropriate environment

where they can share their situation with other people without any fear. Options (a), (c), and (d) all are incorrect.

As per the passage, if any person is facing mental health challenges, the most effective approach to curb it is to make them feel welcomed, to listen to them, rather than judging them. By doing this we make them comfortable, project our acceptance and enable them to share their experiences.

108. Option (a) is correct.

As per the passage, the last component of mental health stigma *i.e.*, behaviour that rise from social isolation, which has been practiced drastically due to the COVID-19 pandemic. The author has discussed the enunciation of the significance of the issue of mental well-being, especially during COVID.

According to option (c), mental health improves when social isolation increases, it in an incorrect statement. Option (b) infers that mental health ailment is because of COVID-19, which is also incorrect.

It had prevailed in the society even before COVID-19. So, the opinion/statement that it will reduce automatically without taking appropriate measures and acknowledging it as an illusionary notion is incorrect.

109. Option (b) is correct.

Option (c) is an incorrect statement because if mental stigma is not related to the economic condition of a country, than the author would not have tagged countries by lower and higher income. As per the passage, options (a) and (d) are incorrect statements.

The above statement is discussing the people of low-income countries and their involvement in day-to-day chores which allow them to interact with other people and not remain isolated. Hence, their stigma-rates are lower than that of higherincome countries.

110. Option (d) is correct.

The thought behind the author's idea of 'having a space where they may be welcomed and listened to, rather than judged' is to provide people an environment, a space where they can be themselves, and can open up and share about their mental issues.

By creating a space where they feel welcomed and listened to, and have no fear of being judged by people. The three options (a), (b), and (c) are all supporting the author's idea, by emphasizing the role of society in embracing people suffering from mental health ailments.

Option (d) is projecting that being judgemental is a human tendency and it needs to be encouraged. This statement contradicts the author's idea of creating a space where people with mental challenges can easily express themselves without being judged.

111. Option (b) is correct.

The opening sentence of the passage says, 'One of the most opportunity, not a threat.' It means that it's a challenge for India to manifest itself as a land of opportunities and not a threat.

Option (c) is an incorrect statement as per the passage. India is seeking out more opportunities to promote economic activities with its neighbours.

As per the passage, India is trying hard to persuade its neighbour and gain economic transactions. Hence, option (a) is incorrect. India is also propagating itself as an opportunity, not a threat, which makes option (d) incorrect.

112. Option (c) is correct.

In context to the given statement, if peace and prosperity cannot work in consonance, then, India cannot fulfill its potential in the world.

Options (b) and (d) contradict the entire notion of the statement. The statement emphasizes living in peace and mutual co-operation.

Option (c) supports the author's opinion of working in peace, harmony, and cooperation.

113. Option (a) is correct.

In the passage, the author has emphasized on the vision of peaceful coexistence of India with its neighbours. The central idea of the passage is to promote not only economic activities between India and its neighbouring countries but also, to promote peaceful co-existence. Refer to these sentences from the passage, 'Economic cooperation chances of success.' Option (d) is emphasizing on the prioritization of economic opportunities, which is incorrect. Options (b) and (c) do not adhere to India's policy of peaceful coexistence and harmony.

Hence, option (a) is the most appropriate option.

114. Option (a) is correct.

Option (c) states that India's accomplishment in the economic sector is preventing its growth and other opportunities, which is incorrect as per the passage.

Refer to these lines from the passage, 'This would go of success.' This statement indicates that India should strive for greater economic integration which should be politically and administratively feasible.

As per the author, India should persuade its neighbours to seek it as an opportunity. Thus, the statement that it is not in India's interest to be generous to its neighbouring countries, and to see borders as barriers and not as gateways of opportunity are both incorrect.

115. Option (d) is correct.

Refer to the statement, 'If India has to fulfill cooperation.' It can be inferred from it that there is a strong link between mutual co-operation amongst nations and their economic well-being.

As per the author, India needs to open its arms and welcome its neighbouring countries if it needs to prosper and flourish holistically. Hence, to be a great power and to escalate its growth, India has to work by collaborating and cooperating with its neighbouring countries.

116. Option (b) is correct.

As per the author, nowadays the decision regarding admission is schools in based on the socio-economic condition of a child's family. This proves that schools in India are segregated based on socio-economic status.

Moreover, according to the author, 'The pandemic internet connectivity'. Thus, due to the pandemic, this socio-economic gap has increased further, which has deteriorated the situation even more. Hence, option (d) is incorrect.

According to the author, 'Most schools mini-armies'. Hence, it can be said that the school system in India follows a generalized pattern, which follows the pattern of one fit for all which makes option (a) incorrect.

As per the passage, 'A.S. Neill way round.', however, schools in India work rigidly, following a set pattern and don't adapt themselves according to a child's needs. This statement makes option (c) is incorrect.

117. Option (a) is correct.

The main concern of the passage is that for a cause like education, in which every citizen has equal rights, socio-economic status of a person should not play any role. On one hand, progressive thinkers envisioned free schools for children while on the other hand, the current situation links a school directly to the socio-economic status of a child. Hence, for the advancement of education in India social segregation must be eliminated. As per the passage, 'The pandemic rich and poor has also widened.' Covid-19 has further enlarged the gap between the rich and the poor. Option (d) is connecting school enrolments with two different factors caste and religion which have not been discussed in the passage.

118. Option (c) is correct.

As per the passage, 'The pandemic has furtheredlearning spaces.' According to the author, Covid-19 has widened the gap between the rich and the poor, because of which opportunities for the poor have further reduced. They cannot afford expensive gadgets which create disruptions in their studies. This leads to disruption in the entire education system. Hence, all the options (a), (b), and (d), except (c) represent the author's view regarding imparting education during the pandemic.

119. Option (c) is correct.

Options (a), (b), and (d) are all features of conventional school setup as per the passage. According to the author, to develop a healthy learning environment for the students, community learning should be encouraged in schools. It will support the idea of free schools too. Communitybased learning is an intentional pedagogical strategy to integrate students learning in academic courses with community engagement.

120. Option (d) is correct.

According to the passage, in a conventional school setup, 'Most schools are caged jails, mini-armies.' Hence, a free school will possess characteristics that are alternative to this mainstream form of schooling. The courses offered in a free school will not follow a fixed and rigid curriculum. It will offer optional courses for students depending on their interests and will provide a free and democratic environment for all the students.

Option (d) is describing characteristics of a conventional school setup; thus, it cannot be referred to as a feature of a free school.

121. Option (b) is correct.

According to the author, 'Just as information decisions.' From these sentences, we can infer that while taking major strategic decisions, climate change needs to be kept in mind and should be a part of the integral checklist. Hence, Option (d) can be inferred from the passage.

Asia world.' By this sentence it can be inferred that it is quintessential to mitigate the effects of climate change. Hence, option (a) is inferable from the above passage.

Refer to these lines from the passage, 'Robust regulations heat waves.' Hence, a feasible solution is to reduce the emissions of such heat waves.

As per the passage, option (b) cannot be inferred, because increase in mitigation strategies will eventually help in regulating and mitigating the harmful effects of climate change.

122. Option (c) is correct.

The word 'implicit', here means something which is implied and can be indirectly deduced from the passage. As per the passage, all three statements are implicit.

Statement II can be inferred from these, 'Climate science continue to rise.'

Statement I can be inferred from these lines, 'Robust regulations heat waves.'

Statement III can be inferred from the Ahmedabad case discussed in the passage. As Ahmedabad authorities has taken initiative and installed heat wave warning system, other cities of the Indian subcontinent need to work at the local level too, to mitigate the climate risk.

123. Option (a) is correct.

Carbon is one of the major elements that play a vital role in the energy sector. 'Carbon pricing' is a market-based strategy for lowering global warming emissions. The aim is to put a price on carbon emissions—an actual monetary value—so that the costs of climate impacts and the

opportunities for low-carbon energy options are better reflected in our production and consumption choices. Hence, option (b) is one of the most effective strategies that can be applied to reduce the climate change risk.

To overcome this problem of carbon emission, industrialists are now moving towards carbon-free operations, which will eventually mitigate climate change risk.

By using adaptive technologies corporate and PSUs are making more eco-friendly infrastructure, which helps in mitigating the climate change risk. By the term adaptive technology, we mean special versions of already existing technology that involves a better and more effective use of it.

Hence, only option (a) is not a feasible strategy to mitigate climate change risk.

124. Option (a) is correct.

As per the passage, 'Renewable energy Central Electricity Authority.' Option (b) is in favour of curbing climate change. Option (a), *i.e.*, reliance on non-renewable energy sources is indeed a major challenge to regulate climate change.

Options (c) and (d) are effective measures to **mitigate** the effects of climate change and **work as a support** mechanism to control its effects.

125. Option (d) is correct.

From the statement, it can be inferred that the author suggests corporate and public-sector to consider climate change and its risks while taking major decisions and making strategies, and build vital infrastructure and utilise tools to diagnose and mitigate them.

Other than option (d), all other three options are negating the statement.

126. Option (a) is correct.

Option (b) is a correct statement as per the passage, but does not represent a holistic reason for the unemployment crisis.

Option (c) is explaining the repercussions of the unemployment, that left people without any job has forced them to migrate back to their home-towns.

Option (d) is incorrect as unemployment rate for the population above the age of 15 has increased, the following lines can be referred, 'While one in five persons above during the same period.'

According to the author, 'While the lockdown longer surprising.' The economy was already going through severe distress and the imposition of lockdown worsened the situation, hence, it is a plausible explanation of India's prevalent unemployment crisis.

127. Option (b) is correct.

According to the passage, there is a sharp rise in the unemployment rate, which is not recent but has been taking place for a very long time. Thus option (c) is incorrect.

'The unemployment...... conflict-ridden countries.' As per the passage, the youth unemployment rate of India is highest in the world excluding small countries, which makes option (d) incorrect.

'While aggregate behind us.' India is still facing the repercussions of contractions in economic activity.

128. Option (c) is correct.

The word 'attributable' means, cause of any particular event or situation. As per the passage, imposition of nationwide lockdown resulted in the loss of livelihoods, decline in economic growth and rise in unemployment rate. Hence, options (a), (b) and (d) can be inferred from the passage. But, option (c) is a result of the lockdown and not a cause of it.

129. Option (c) is correct.

Option (a) is elaborating the youth unemployment rate scenario, but the author's argument is about overall economic growth. Moreover, both options (a) and (b) are just discussing about 2020 statistics and are not providing any information about the previous years' numbers.

Option (c) is discussing about past years' data and is exhibiting the decline in percentage. It clearly states that the growth rate was already decelerating and Covid-19 has made the situation worse. Hence, it is supporting the author's argument that the decline in economic growth and rise in unemployment precedes the onset of the COVID-19 pandemic.

130. Option (a) is correct.

Refer to these lines of the passage, 'The unemployment the world'. Options (b) and (d) are discussing about increase in employment rates, which is incorrect.

Option (c) is explaining increase in unemployment rates by three per cent, which is incorrect. As per the passage the unemployment rates in urban areas were increased almost three times.

131. Option (a) is correct.

According to the author, the passage is all about applauding India for handling the Covid-19 uprising curve, better than most advanced nations, and justifying that the data presented has not been forged in any sense. Option (b), (c), and (d) are all weakening the given argument and are contradicting the fact presented in the passage.

Whereas option (a) is supporting the idea presented by the author, that reduction in cases and admissions in Indian hospitals projects that overall COVID-19 cases are also declining.

132. Option (b) is correct.

As per the passage, India is handling and has tackled the COVID-19 pandemic better than most advanced nations. It has not tried to manipulate or forge data. Option (a) is supporting the part of the passage in which the author is justifying that India is not at all fudging data as doing such a scam needs a lot of co-ordination and effort, and India lacks it. Evidence points to the fact that India has flattened the corona curve and has not imposed draconian lockdowns for doing so. These statements entirely support the author's idea behind the passage. However, if option (b) is true, it will contradict the idea presented by the author and will shake the argument. If Indians are not getting tested then the author's claim proves to be false.

133. Option (c) is correct.

In the given statement, the author has used some prime key phrases 'to think' and 'giving away too much credit'. It means that there is a possibility that there may be some unauthorized networks that are operating independently at state and district levels.

Hence, options (a) and (b) are incorrect. As (a) is showing certainty about the existence of these networks and (b) is proclaiming them to be authorized.

Both options (c) and (d) both are showing a possibility of the presence of these unauthorized networks but as per the passage, the author is skeptical about them and questioning their presence. Hence, (c) is the correct answer.

134. Option (a) is correct.

According to the author, 'If and when major celebrations.' which makes option (b) to be true as nobody is acknowledging India for the achievement, rather it has been questioned for the credibility of the data.

These lines from the passage, 'However, because our own.' identifies option (c) to be true.

'We aren't counting work in India.' Many times questions have been raised on India's capability of handling the pandemic, which makes option (d) to be true.

As per the passage, few developed nations, are reluctant to learn from India. The author is not talking about all the developed countries here. Moreover, these countries are not eager to learn from India as India is considered a poor nation, incapable, and a third-world country.

135. Option (d) is correct.

Refer to these lines from the passage, 'What is evenopened up more'. These lines clearly indicate that cases have dropped despite the loosening of restrictions. Hence, option (d) is correct.

Option (a) is establishing a cause-and-effect relationship between reduction of restrictions and cases which is invalid as per the passage.

Option (b) is about an increase in the number of cases due to a reduction in restrictions, which is false. Option (c) relates the reduction of cases with the increase in restrictions which is false.
